

Senior and Former Judges

Available to Serve on Assignment

The following information on Senior and Former Judges available for assignment was obtained from the Presiding Judges of the Administrative Judicial Regions (AJRs), and is current as of February 2009. For an updated list of the judges available for assignment in a particular region and/or the current status and phone number for a judge on this list, please contact the relevant AJR (as indicated in the third column).

Column 2 below indicates the judge's status as of February 2009; this column does not indicate the judge's status at the time the judge left office for purposes of objecting to an assigned judge per Section 74.053, Government Code. As used in this directory, "former" indicates a judge who served as a regular judge for at least 48 months and has not yet retired (i.e., a judge who is not receiving an annuity under the Judicial Retirement System), and "senior" indicates a judge who served as a regular judge for at least 48 months and has retired (i.e., a judge who is receiving an annuity under the Judicial Retirement System).
