Under the provisions of Section 413.031 of the Texas Workers' Compensation Act, Title 5, Subtitle A of the Texas Labor Code, effective January 1, 2002 and Commission Rule 133.305 and 133.308 titled Medical Dispute Resolution by Independent Review Organizations, the Medical Review Division assigned an IRO to conduct a review of the disputed medical necessity issues between the requestor and the respondent.

The Medical Review Division has reviewed the IRO decision and determined that **the requestor prevailed** on the issues of medical necessity. Therefore, upon receipt of this Order and in accordance with §133.308(q)(9), the Commission hereby orders the respondent and non-prevailing party to **refund the requestor \$650.00** for the paid IRO fee. For the purposes of determining compliance with the order, the Commission will add 20 days to the date the order was deemed received as outlined on page one of this order.

In accordance with §413.031(e), it is a defense for the carrier if the carrier timely complies with the IRO decision.

Based on review of the disputed issues within the request, the Medical Review Division has determined that **medical necessity was the only issue** to be resolved. The reading of x-ray of right hip was found to be medically necessary. The respondent raised no other reasons for denying reimbursement for these reading of x-ray of right hip charges.

On this basis, and pursuant to §§402.042, 413.016, 413.031, and 413.019 of the Act, the Medical Review Division hereby ORDERS the respondent to pay the unpaid medical fees in accordance with the fair and reasonable rate as set forth in Commission Rule 133.1(a)(8) plus all accrued interest due at the time of payment to the requestor within 20 days of receipt of this order. This Order is applicable to date of service 4/4/02 in this dispute.

The respondent is prohibited from asserting additional denial reasons relative to this Decision upon issuing payment to the requestor in accordance with this Order (Rule 133.307(j)(2)).

In performing this review, \_\_\_ reviewed relevant medical records, any documents provided by the parties referenced above, and any documentation and written information submitted in support of the dispute.

The independent review was performed by a matched peer with the treating health care provider. This case was reviewed by a physician who is certified in Chiropractic medicine.

Clinical History:

This claimant injured his right hip on the job on \_\_\_\_. He sought care on 04/03/02, when an examination and appropriate x-rays were performed. In addition, the x-rays of the right hip were submitted to the radiologist for follow-up review. A treatment program was begun; as well as additional diagnostic tests were performed.

Disputed Services:

Second-opinion reading of x-ray to right hip.

Decision:

The reviewer disagrees with the determination of the insurance carrier. The reviewer is of the opinion that the reading of the x-ray was medically necessary in this case.

Rationale for Decision:

It is well documented and accepted in the medical and chiropractic professions, and is usual and customary to have x-rays reviewed by radiologists. Therefore, it was, in fact, reasonable, usual, customary and medically necessary to have these x-rays taken in the office reviewed by a radiologist.
