Under the provisions of Section 413.031 of the Texas Workers' Compensation Act, Title 5, Subtitle A of the Texas Labor Code, effective June 17, 2001 and Commission Rule 133.305 titled Medical Dispute Resolution - General and 133.308 titled Medical Dispute Resolution by Independent Review Organizations, the Medical Review Division (Division) assigned an IRO to conduct a review of the disputed medical necessity issues between the requestor and the respondent. The dispute was received on August 11, 2003.

The Medical Review Division has reviewed the IRO decision and determined that **the requestor prevailed** on the issues of medical necessity. Therefore, upon receipt of this Order and in accordance with § 133.308(r)(9), the Commission hereby Orders the respondent and non-prevailing party to **refund the requestor \$650.00** for the paid IRO fee. For the purposes of determining compliance with the Order, the Commission will add 20-days to the date the Order was deemed received as outlined on page one of this Order.

In accordance with §413.031(e), it is a defense for the carrier if the carrier timely complies with the IRO decision.

Based on review of the disputed issues within the request, the Medical Review Division has determined that **medical necessity was the only issue** to be resolved. The therapeutic exercises, hot/cold packs, office visits, and ultrasound therapy were found to be medically necessary. The respondent raised no other reasons for denying reimbursement for therapeutic exercises, hot/cold packs, office visits, and ultrasound therapy charges.

This Findings and Decision is hereby issued this 4th day of November 2003.

This Order is applicable to dates of service 9/18/02 through 11/22/02 in this dispute.

The respondent is prohibited from asserting additional denial reasons relative to this Decision upon issuing payment to the requestor in accordance with this Order (Rule 133.307(j)(2)).

NOTICE OF INDEPENDENT REVIEW DECISION

___ has been certified by the Texas Department of Insurance (TDI) as an independent review organization (IRO). The Texas Workers' Compensation Commission (TWCC) has assigned the above referenced case to ___ for independent review in accordance with TWCC Rule §133.308 which allows for medical dispute resolution by an IRO.

___ has performed an independent review of the proposed care to determine if the adverse determination was appropriate. In performing this review, relevant medical records, any documents utilized by the parties referenced above in making the adverse determination, and any documentation and written information submitted in support of the appeal was reviewed.

The independent review was performed by a ___ physician reviewer who is board certified in internal medicine which is the same specialty as the treating physician. The ___ physician reviewer has signed a certification statement stating that no known conflicts of interest exist between him or her and any of the treating physicians or providers or any of the physicians or providers who reviewed the case for a determination prior to the referral to ___ for independent review. In addition, the reviewer has certified that the review was performed without bias for or against any party to this case.

Clinical History

This patient sustained a right shoulder re-injury on ___, mechanism unknown. She had previous shoulder surgery in 1995 and underwent an arthroscopy right shoulder and distal clavicle resection and debridement of scar tissue subacromial joint on 07/30/02. The patient attended post operative physical therapy.

Requested Service(s)

Therapeutic exercises, hot or cold packs, office visits, and ultrasound therapy from 09/18/02 through 11/22/02

Decision

It is determined that the therapeutic exercises, hot or cold packs, office visits, and ultrasound therapy from 09/18/02 through 11/22/02 are medically necessary to treat this patient's condition.

Rationale/Basis for Decision

The patient presented with apparent documentation of limitation of movement on follow-up visit. In the view of the orthopedic surgeon, the therapies in dispute are indicated to improve range of motion and improve quality of life post operatively. The documentation reflects an improvement in movement with these therapies. Therefore, it is determined that the therapeutic exercises, hot or cold packs, office visits, and ultrasound therapy from 09/18/02 through 11/22/02 are medically necessary.

This decision by the IRO is deemed to be a TWCC decision and order.

YOUR RIGHT TO REQUEST A HEARING

Either party to this medical dispute may disagree with all or part of the decision and has a right to request a hearing.

If disputing a spinal surgery prospective decision a request for a hearing must be in writing and it must be received by the TWCC Chief Clerk of Proceedings within **10** (ten) calendar days of your receipt of this decision (28 Tex. Admin. Code 142.5 (c)).

If disputing other prospective medical necessity (preauthorization) decisions a request for a hearing must be in writing, and it must be received by the TWCC Chief Clerk of Proceedings within **20** (twenty) calendar days of your receipt of this decision (28 Tex. Admin. Code 142.5(c)).

This decision is deemed received by you 5 (five) days after it was mailed or the date of fax (28 Tex. Admin. Code 102.5(d)). A request for hearing and a **copy of this decision** must be sent to: Chief Clerk of Proceedings/Appeals Clerk, Texas Workers' Compensation Commission, P.O. The party appealing this decision shall deliver a copy of its written request for a hearing to all other parties involved in this dispute.
