PART III: REQUESTOR'S POSITION SUMMARY

TWCC Rule 134.401 provides the rules regarding reimbursement for Acute Care In-patient Hospital Fee services. Specifically, reimbursement consists of 75% of remaining charges for the entire admission, after a Carrier audits a bill.

PART IV: RESPONDENT'S POSITION SUMMARY

To invoke the Stop-Loss reimbursement provisions, Requestor must meet two criteria: (1) the audited charges must exceed \$40,000.00, the minimum stop-loss threshold, and (2) the services made the basis of the charges must be unusually extensive/costly.

PART V: MEDICAL DISPUTE RESOLUTION REVIEW SUMMARY, METHODOLOGY, AND/OR EXPLANATION

This dispute relates to inpatient services provided in hospital setting with reimbursement subject to the provisions of Rule 134.401 (Acute Care Inpatient Hospital Fee Guideline). The hospital has requested additional reimbursement according to the stop-loss method contained in that rule. Rule 134.401(c)(6) establishes that the stop-loss method is to be used for "unusually costly services." The explanation that follows this paragraph indicates that in order to determine if "unusually costly services" were provided, the admission must not only exceed \$40,000 in total audited charges, but also involve "unusually extensive services."

After reviewing the documentation provided by the provider, it does **not** appear that this particular admission involved "unusually extensive services." Accordingly, the stop-loss method does not apply and the reimbursement is to be based on the per diem plus carve-out methodology described in the same rule.

The total length of stay for this admission was five (5) days (consisting of 5 days for surgical). Accordingly, the standard per diem amount due for this admission is equal to \$5,590.00 (5 X \$1,118.00), however, the requestor billed \$4,381.25. In addition, the hospital is entitled to additional reimbursement for (implantables/MRIs/CAT Scans/pharmaceuticals) as follows:

Invoice from Lifelink Tissue Bank in amount of $\$1,254.00 \times 10\% = \$1,379.40$ Invoice from DePuy Spine in amount of $\$570.00 \times 10\% = \627.00 Invoice from Commercial Capital A/C Spinal Solutions in amount of $\$10,545.00 \times 10\% = \$11,599.50$

The carrier has reimbursed the provider \$37,336.01.					
Considering the reimbursement amount calculated in accordance with the provisions of rule 134.401(c) compared with the amount previously paid by the insurance carrier, we find that no additional reimbursement is due for these services.
