PART III: REQUESTOR'S POSITION SUMMARY

A Position Summary was not submitted by the Requestor; however, the Requestor's rationale on the Table of Disputed Services states, "Per TWCC guideline total charges exceed \$40k, therefore stoploss applies. Implants are not considered auditable charges."

PART IV: RESPONDENT'S POSITION SUMMARY

Respondent did not submit a Position Summary.

PART V: MEDICAL DISPUTE RESOLUTION REVIEW SUMMARY, METHODOLOGY, AND/OR EXPLANATION

This dispute relates to inpatient services provided in hospital setting with reimbursement subject to the provisions of Rule 134.401 (Acute Care Inpatient Hospital Fee Guideline). The hospital has requested reimbursement according to the stop-loss method contained in that rule. Rule 134.401(c)(6) establishes that the stop-loss method is to be used for "unusually costly services." The explanation that follows this paragraph indicates that in order to determine if "unusually costly services" were provided, the admission must not only exceed \$40,000 in total audited charges, but also involve "unusually extensive services."

After reviewing the documentation provided by both parties, it does **not** appear that this particular admission involved "unusually extensive services." Accordingly, the stop-loss method does not apply and the reimbursement is to be based on the per diem plus carve-out methodology described in the same rule.

The total length of stay for this admission was 3 days (consisting of 3 days in an intense care unit). Accordingly, the standard per diem amount due for this admission is equal to \$4,680.00 (3 times \$1,560). In addition, the hospital is entitled to additional reimbursement for (implantables/MRIs/CAT Scans/pharmaceuticals) as follows:

DePuy AcroMed Invoice:	\$7,602.48	x 10%	= \$ 8,362.73
3 day LOS in ICU:	\$1,560.00	x 3	= <u>4,680.00</u>
Total:			\$13,042.73

The Requestor billed \$42,712.78 and received reimbursement totaling \$13,042.73. Considering the reimbursement amount calculated in accordance with the provisions of rule 134.401(c) compared with the amount previously paid by the insurance carrier, we find that no additional reimbursement is due for these services.

PART VI: COMMISSION DECISION

Based upon the review of the disputed healthcare services, the Medical Review Division has determined that the requestor is **not** entitled to additional reimbursement.
