

# MEDICAL DISPUTE RESOLUTION FINDINGS AND DECISION

## PART III: REQUESTOR'S POSITION SUMMARY

IC failed to pay per TWCC Rule 134.401 Acute Care Inpatient Hospital Fee Guideline and SOAH decision 453-04-3600.M4...Per TWCC Rule 134.401(c)(6)...claim pays @ 75% of total charges as charges exceed \$40,000.00 stop-loss threshold. Carrier further failed to audit according to TWCC Rule 134.401(C)(6)(A)(v).

## PART IV: RESPONDENT'S POSITION SUMMARY

Requestor billed a total of \$82,470.94. The Requestor asserts it is entitled to reimbursement in the amount of \$55,581.84, which is 75% of the total charges. Requestor has not shown entitlement to this alternative, exceptional method of calculating reimbursement and has not otherwise properly calculated the audited charges.

## PART V: MEDICAL DISPUTE RESOLUTION REVIEW SUMMARY, METHODOLOGY, AND/OR EXPLANATION

This dispute relates to inpatient services provided in hospital setting with reimbursement subject to the provisions of Rule 134.401 (Acute Care Inpatient Hospital Fee Guideline). The hospital has requested reimbursement according to the stop-loss method contained in that rule. Rule 134.401(c)(6) establishes that the stop-loss method is to be used for "unusually costly services." The explanation that follows this paragraph indicates that in order to determine if "unusually costly services" were provided, the admission must not only exceed \$40,000 in total audited charges, but also involve "unusually extensive services."

After reviewing the documentation provided by both parties, it **does** appear that this particular admission involved "unusually extensive services." In particular, this admission resulted in a hospital stay of 4 days based upon L3-5 bilateral laminectomy and foraminotomy; posterior lumbar interbody arthrodesis L3-5, Posterior lumbar interbody instrumentation, two Brantigan cages L3-5 and pedicle screws and rods; posterior lumbar arthrodesis L3-5; and harvesting bone graft. Accordingly, the stop-loss method does apply and the reimbursement is to be based on the stop-loss methodology.

The requestor billed \$109,961.25 for the hospitalization. In determining the total audited charges, it must be noted that the insurance carrier has indicated some question regarding the charges for the implantables. The requestor billed \$63,402.00 for the implantables. The respondent paid \$20,662.40 based upon fee guideline and not documented. Based on a reimbursement of \$20,662.40, it appears that the carrier found that the cost for the implantables was \$18,784.00 (reimbursed amount divided by 110%). This amount multiplied by the average mark-up of 200% results in an audited charge for implantables equal to \$37,568.00.

The audited charges for this admission, excluding implantables, equals \$46,559.25. This amount plus the above calculated audited charges for the implantables equals \$84,127.25. the total audited charges. This amount multiplied by the stop-loss reimbursement factor

(75%) results in a workers' compensation reimbursement amount equal to \$63,095.43.

The insurance carrier audited the bill and paid \$55,581.84 for the inpatient hospitalization. The difference between amount paid and amount due = \$7513.59.

Based on the facts of this situation, the parties' positions, and the application of the provisions of Rule 134.401(c), we find that the health care provider is entitled to a reimbursement amount for these services equal to \$7513.59.

**PART VI: COMMISSION DECISION AND ORDER**

Based upon the review of the disputed healthcare services, the Medical Review Division has determined that the requestor is entitled to additional reimbursement in the amount of \$7513.59. The Division hereby **ORDERS** the insurance carrier to remit this amount plus all accrued interest due at the time of payment to the Requestor within 20-days of receipt of this Order.
