Notice is hereby given that the City of Killeen will receive sealed bids for the construction of C.I.P. # 5 WOODROW DRIVE DRAINAGE IMPROVEMENTS – PHASE I PROJECT, addressed to Kristina Ramirez, P.E., Project Engineer - Drainage Utilities, City of Killeen, in the Public Works Department located within the City Hall Annex, Second Floor, Room 216, 200 East Avenue D (Southeast Corner of 4<sup>th</sup> Street and Avenue D), Killeen, Texas 76541, until 2:00 p.m. on October 28, 2009, at which time the bids shall be publicly opened and read aloud in the Public Works Conference Room, City Hall Annex, Second Floor, Room 214, 200 East Avenue D (Southeast Corner of 4<sup>th</sup> Street and Avenue D). Any bid received after the closing time will be returned unopened. Bid shall be plainly marked with the name and address of the bidder and “BID NO. 09-31 – C.I.P. # 5 WOODROW DRIVE DRAINAGE IMPROVEMENTS – PHASE I PROJECT, CITY OF KILLEEN, TEXAS”.

Major items of construction include approximately: 106 LF of 8’x 6’ Precast RCB, 456 LF of 72” RCP Storm Sewer Pipe, 106 LF of 42” RCP Storm Sewer Pipe, 1 EA of 8’x 6’ Precast RCB 13 Degree Bend, 1 EA of 8’x 6’ Precast RCB 47 Degree Bend, 1 EA of 8’x 6’ Precast RCB 60 Degree Bend, 1 EA of 10’x 4’ Concrete Junction Box, 1 EA of TxDOT Parallel Concrete Headwall, 2 EA of 20’ Grated Curb Inlet, 5 EA of 10’ Grated Curb Inlet, 3 EA of 4’ Diameter Concrete Manhole, and 669 LF of 6” SDR-26 PVC Wastewater Pipe.

The pre-bid conference will be held at 2:00 p.m. on October 21, 2009 in the Public Works Conference Room located within the City Hall Annex, Second Floor, Room 214, 200 East Avenue D (Southeast corner of 4<sup>th</sup> Street and Avenue D), Killeen, Texas 76541. Pre-bid questions will be accepted up to 2:00 p.m. on October 26, 2009, (48 hours prior to bid opening).

Bids must be submitted on the bid forms provided by the City and accompanied by a bid security in an amount of five percent (5%) of the amount of the base bid, payable, without recourse, to the City of Killeen. The security may be in the form of a certified cashier’s check or a Bid Bond in the same amount from a reliable surety company approved to do business in the State of Texas, as guarantee that the bidder will enter into a contract and execute a 100 percent performance bond and 100 percent payment bond and guaranty forms provided within ten (10) business days after notice of award of contract to him. Bids not accompanied by cashier’s check or bid bond will not be considered.
