The Tomball Fire Dept. is pleased to announce the opening of its Southside Fire Station, located at 11675 Holderrieth, across the street from Houston Polybag. The station will serve eastern and southern portions of the Department's response district. The 7,500-foot building is home to an engine, tanker and a brush truck.

It is anticipated that the station will be manned by three part-time paid firefighters during daytime hours and by volunteers during remaining periods.



The station will accommodate both male and female firefighters and has limited office space. The building was constructed with a fire sprinkler for additional safety, has its own backup power system, and was built to withstand 115 mph

winds. Carl Joiner Partnership, Architects designed the building and it was constructed by Thomas E. Rack Company. The Fire Department is looking forward to a "Grand Opening" in late September.

# **New Meters!**

The Utility Department has implemented a new Meter Replacement Program which involves the installation of the Automatic Meter Reading System (AMR) for water and gas meters. With automation, manual reading, writing and keyboarding errors are eliminated. Meter-reading time is also reduced. Within the last month, the Water and Gas Department has installed approximately 760 new AMR meters.








# City of Tomball Prepares for a New Fiscal Year 2006-2007 Budget

City Council prepared the budget based on two major goals, to keep the property tax burden low and to provide the highest possible service. Adoption of the proposed budget is scheduled for September 5, 2006.

# **Changes in Utility Rates**

The City's Fiscal Year and new budget start October 1, 2006. Effective October 1st, the City will be implementing new utility rates in order to recoup the increased costs of operations, including fuel,

energy and construction costs. Water and sewer rates will increase by 5%, garbage rates by 5.8% and natural gas will be at the current market rate. The city had a fixed contract rate for natural gas for the previous three years, but with the increased prices of oil and natural gas, we have not been able to lock in at a below market rate for the remainder of 2006 and 2007.

The chart below shows the impact on the <u>average</u> utility bill. By taking totals for a year and dividing by 12, this averages for seasonal differences. Sewer rates are based on your <u>average usage between November and February of the previous year</u>, when water usage is normally at its lowest.

# **Utility Customer Options**

## Senior Citizen and Disabled Program

The City of Tomball is aware of the fixed income status of our Senior Citizens that are over 65, and our citizens who are disabled. Because the majority of these citizens receive their income after the billing due date, the City may dismiss, at their discretion, the late penalties for the current billing cycle. A copy of your Texas Driver's License or Texas Identification Card will be required. For the disabled, a copy of your papers from Social Security showing the disability status is needed on file in the Utilities Department. Please see one of the clerks at Public Works for more information.

### Average Monthly Payment Plan

The Average Monthly Payment (AMP) Plan is designed so that the program will average your bills over a twelve (12) month period. In order to qualify for enrollment, you must have lived at your service address for at least twelve billing cycles. Please see one of the clerks at Public Works for more information.

## Automatic Draft


Customers may elect to have their utility bill payments automatically drafted out of their bank account.



## **Taxes**

#### **Property Tax Rates**

Property tax rates will remain at \$0.28 per \$100 of valuation. This Property Tax Rate has been in effect since the 2002-2003 Fiscal Year. The City has been able to keep the Property Taxes down because of the revenues received from taxable retail sales within the Tomball city limits.





#### Sales Tax Revenues

In 1991, taxpayers voted to reduce property taxes by increasing the sales tax rate by one-half cent. This change became effective in December 1991. Over the past ten years, sales tax revenues have increased 151% from \$2,612,611 to \$6,555,372. This reflects strong economic growth and is the primary reason that the City's Property Tax rate is so low.
