#### 8.0 **Old Business**

8.1 Mark McClure provided overview of recommended increases in impact fees for drainage, water, and wastewater. Motion was made by Councilman Townsend, second by Councilman Driver to Adopt, on Second Reading, Ordinance No. 2009-12, an Ordinance amending the Code of Ordinances of the City of Tomball, Texas, by adopting the Infrastructure Master Plan and Impact Fee Determination 2007-2017 as the City's Capital Improvements Plan; amending Sec. 156. Schedule of Maximum Capital Recovery Fees of Chapter 82. Utilities thereof, establishing Impact Fees for Water, Wastewater and Drainage Utilities; and containing other Provisions Relating to the Subject. Vote was as follows:

8.2 Kelly Violette provided overview of the zoning request. Motion was made by Councilman Lazenby, second by Councilman Webb, to Adopt, on Second Reading, Ordinance No. 2009-13, an Ordinance of the City of Tomball, Texas, Amending its Comprehensive Zoning Ordinance by changing the Zoning District Classification of approximately 3.09 Acres of land in the Jesse Pruitt Survey, Abstract 629, Harris County, Texas, from the SF-20-E-Single-Family Estate Residential-20 District to the C-Commercial District; said property also being known as Tracts 197A & 197A-1 of the Tomball Outlots, located on the easterly side of South Cherry Street, northerly of Theis Lane; Providing for the amendment of the Official Zoning Map of the City; providing for Severability; Providing for a Penalty of an amount not to exceed \$2,000 for each day of violation of any Provision Hereof, Making Findings of Fact; and Providing for Other Related Matters. Vote was as follows:

8.3 Kelly Violette provided overview of the zoning request. Motion was made by Councilman Townsend, second by Councilman Driver, to Adopt, on Second Reading, Ordinance No. 2009-14, an Ordinance of the City of Tomball, Texas, Amending its Comprehensive Zoning Ordinance by changing the Zoning District Classification of approximately 7.8041 acres of land in the C.N. Pillot Survey, Abstract 632, Harris County, Texas, from the AG-Agricultural District to the C-Commercial District; said property also being known as Lots 1 and 2 of Block 1 of the Tomball Renewal Center Plat, located on the easterly side of Cherry Street, northerly of Holderrieth Road; Providing for the Amendment of the Official Zoning Map of the City; Providing for Severability; Providing for a Penalty of an Amount not to Exceed \$2,000 for each day of Violation of Any Provision Hereof, Making Findings of Fact; and Providing for Other Related Matters. - 8.4 Mayor Fagan presented the list of Livable Centers Advisory Committee members, advising Council that the Livable Centers Advisory Committee is an ad hoc group with no voting authority and their work is basically complete. Jan Belcher advised Council that the recommendations from the consultant would be made to the Planning and Zoning Commission and the City Council at a later date. No action was necessary.
- 8.5 Motion was made by Councilman Townsend, second by Councilman Driver, to receive the requested update regarding the director position to be appointed by City Council. Scott Bounds presented information regarding appointment of a Council representative to the NWEMS Board of Directors; Council may, but is not required to, appoint a representative to the NWEMS Board and the appointee can, but does not have to, be a Councilmember. The director position is a voting position. No action was necessary; an item to consider the appointment of a representative to the NWEMS Board of Directors will be placed on the next agenda.

9.2 Mark McClure provided information regarding Project Number 2006-10000. Motion was made by Councilman Driver, second by Councilman Quinn, to award the Contract for Project Number 2006-10000, Water Supply & Storage Facility No. 5, to Low Bidder, Schier Construction Company, Inc., in the amount of \$3,150,600.00.

9.3 Mark McClure provided information regarding the Jansep Investments plat. Motion was made by Councilman Driver, second by Councilman Webb, to approve <u>JANSEP</u> <u>INVESTMENTS</u>: A Final Plat of 3.8468 acres, containing 1 Lot, 1 Block, located in the Jesse Pruitt Survey, A-629, Harris County, Texas, as Recommended by Planning and Zoning Commission.

- 9.4 Shawn Cox provided information regarding the proposed changes to the current Community Center use policy. Consensus of Council was unanimous that the proposed changes are necessary. No action was taken; an item to consider the proposed changes to Administrative Policy No. 15, "Tomball Community Center Policies and Operating Procedures" will be placed on a future agenda.
