- Mayor Fagan announced that the portion of the scheduled Public Hearing for **ZONING** <u>CASE P08-074</u>: Request by James E. Spurlin with L.S. Development L.L.C. to amend the Comprehensive Zoning Ordinance to rezone a 142.770 acre tract of land in the Joseph Miller Survey, Abstract No. 50, within the City of Tomball, Harris County, Texas, generally located northerly of Zion Road, easterly of Neal Street, from the AG-Agricultural District to the SF-9- Single Family 9 District was canceled; Zoning Case P08-074 has been tabled by the Planning and Zoning Commission and additional public hearing notification will be required before a new public hearing is held.

Maximum Sound Levels, of Chapter 14. Buildings and Building Regulations, by Providing a New Section 14-8, by Deleting Article V. Noise of Chapter 30-Environment, by Providing a New Article V of Chapter 30, all Prohibiting and Regulating Certain Noises; Establishing Rules and Regulations for the Permitting and Operation of Certain Noise-Making Activities and Devices; Providing a Penalty in an Amount Not to Exceed \$500 for Each Violation Hereof; and Providing for Severability; and Making Other Provisions and Findings Related Thereto; second by Councilman Harvey. Automated Red Light Enforcement, by Deleting Section 78-224. Administrative Adjudication Hearing and by Providing a New Section 78-224. Administrative Adjudication Hearing, Extending the Period in Which the Administrative Adjudication Hearing Must be Held to 180 Days; Providing for Severability; and Making Other Provisions and Findings Related Thereto; second by Councilman Harvey. 8.4 Mark McClure presented information regarding the proposed amendment to the development agreement with Tomball Spring Creek Commons. Motion was made by

Councilman Harvey to Approve Amendment Number One to Agreement with Tomball Spring Creek Commons, L.P. for Construction of M124 Drainage Improvements; second by Councilman Lazenby.

8.5 Jan Belcher advised Council that the date for the public hearing on the land use assumptions and capital improvements plan had been stated incorrectly in Resolution No. 2009-02 and this resolution would correct the error. Motion was made by Councilman Webb to Approve Resolution No. 2009-02C, a Resolution of the City Council of the City of Tomball, Texas, Amending Resolution 2009-02, Approved on January 5, 2009; to Correct the Date Set for the Public Hearing on Land Use Assumptions and Capital Improvements Plan Relating to Possible Adoption of Impact Fees to February 16, 2009 at 6:30 P.M; Making Other Findings and Providing Details Related Thereto; Repealing All Resolutions and Orders or Parts Thereof Inconsistent or in Conflict Herewith; and Providing for Severability; second by Councilman Driver.

8.6 Rob Hauck presented information regarding the proposed mutual aid law enforcement agreement between the City and Lonestar College-Tomball. Motion by Councilman Harvey to Approve Resolution No. 2009-04, a Resolution of the City Council of the City of Tomball, Texas, Approving a Mutual Aid Law Enforcement Agreement between the City of Tomball and Lonestar College System-Tomball to Facilitate Assistance and Cooperation in the Investigation of Criminal Activity and Law Enforcement on an As-needed and Asrequired Basis; Authorizing the Chief of Police to Execute the Mutual Aid Law Enforcement Agreement on Behalf of the City of Tomball; Containing other Provisions relating to the Subject; and Providing for Severability; second by Councilman Lazenby.

8.7 Jan Belcher presented information regarding the rates proposed by the Tribune and the Potpourri and reminded Council the Allen Jones, editor of the Potpourri, had committed to Council that the Potpourri would match the rates currently being charged by the Tribune. Motion was made by Councilman Quinn to Approve Resolution No. 2009-05, a Resolution of the City Council of the City of Tomball, Texas, Designating the Official Newspaper for 2009 for Publication of Matters Pertaining to the City of Tomball, and designating the Tomball-Magnolia Potpourri as the Official Newspaper for the City of Tomball 2009, based on the commitment made by Allen Jones during Public Comments to match the rates currently being charged by the Tomball-Magnolia Tribune; second by Councilman Webb.

Entitled "Charitable Organization Exemption"; Providing a Property Tax Exemption for Qualified Charitable Organizations Engaged Primarily in Performing Religious, Charitable, Scientific, Literary, or Educational Functions; Requiring a Determination Letter from the State Comptroller's Office Finding the Organization is Engaged Primarily in Performing Religious, Charitable, Scientific, Literary, or Educational Functions; Providing a Five (5) Year Term for the Property Tax Exemption; Providing a Severability Clause; and Providing for an Effective Date; second by Councilman Driver. The Public Hearing for <u>ZONING CASE P08-082</u>, requested by Nancy Gomez to amend the Comprehensive Zoning Ordinance to rezone one tract totaling approximately 2.5 acres of land, legally described as Tract 42B situated in the Tomball Townsite, Ralph Hubbard Survey, Abstract 383, (1230 Ulrich Road) within the City of Tomball, Harris County, Texas, generally bounded by Ulrich Road and Rudolph Road, northerly of East Hufsmith Road, from the SF-20-E - Single-Family 20 Estate District to the GR-General Retail District was opened by Mayor Fagan at 7:47 p.m.; the following comments were received:

8.10 Kelly Violette presented the staff report for Zoning Case P08-088, LS Development, LLC. The Public Hearing for <u>ZONING CASE P08-088</u>, requested by Jason Atkinson, on behalf of James E. Spurlin with L.S. Development L.L.C., for a text amendment to Section 16.4 (A.2) of the Comprehensive Zoning Ordinance to reduce the minimum lot width requirement of a radial lot from 80 feet to 75 feet at and for a distance of 30 feet behind the front yard/building line was opened by Mayor Fagan at 8:02 p.m.; the following comments were received:

Motion was made by Councilman Driver to Adopt, on First Reading, Ordinance No. 2009-06, an Ordinance of the City of Tomball, Texas, Amending its Comprehensive Zoning Ordinance by amending Section 16.4 SF-9-Single-Family Residential-9 District Area Regulations to Decrease the Minimum Lot Width Requirement for Radial Lots to 75 feet from 80 feet; Providing for Severability; Providing for a Penalty of an Amount Not to Exceed \$2,000 for Each Day of Violation of Any Provision Hereof; Making Findings of Fact; and Providing for Other Related Matters; second by Councilman Quinn.

Motion was made by Councilman Quinn to table consideration of this request until Raleigh Creek presents a rezoning request for the development; second by Councilman Webb.

Motion to **TABLE** consideration of this request carried unanimously. No action taken regarding Ordinance No. 2009-06.

8.11 Monica Kohlenberg presented proposed administrative policy covering the grant application process for hotel/motel tax revenue. Motion was made by Councilman Lazenby to Approve Administrative Policy No. 22, Entitled "Hotel Occupancy Tax Grant Process"; second by Councilman Harvey.
