8.1 Doris Speer presented an overview of the request by TxDOT for the City to adopt new speed zones. Motion was made by Councilman Townsend, second by Councilman Driver, to read Ordinance No. 2009-18, by caption only, on first reading.

Motion was made by Councilman Townsend, second by Councilman Stoll, to Adopt, on First Reading, Ordinance No. 2009-18, An Ordinance Altering the *Prima Facie* Speed Limits Established for Vehicles under the Provisions of §545.356, Texas Transportation Code, upon the Basis of an Engineering and Traffic Investigation, upon Certain Streets and Highways, or Parts Thereof, within the Corporate Limits of the City of Tomball, as set out

in this Ordinance; and Providing a Penalty of a Fine in an Amount Not to Exceed Two Hundred Dollars (\$200.00) for the Violation of this Ordinance (SH 249/Tomball Expressway). Councilman Townsend requested that TxDOT adhere to the federal regulations for the size of speed limit signs. Vote was as follows:

9.2 Doris Speer provided an overview of the Tomball High School Student Council's request for the use of the Depot. Motion was made by Councilman Webb, second by Councilman Driver, to Approve Resolution No. 2009-18, a Resolution of the City Council of the City of Tomball, Texas, Supporting the 2nd Annual Homecoming Parade and Pep Rally, to be held at the Tomball Depot, Sponsored by the Tomball Independent School District and the TISD Student Council, on Wednesday, October 21, 2009.

9.3 Motion was made by Councilman Webb, second by Councilman Townsend to Approve Resolution No. 2009-19, a Resolution of the City of Tomball, Texas, Replacing the City of Tomball's Personnel Policy in its Entirety with the "Human Resources Policies and Employee Handbook". Motion was made by Councilman Townsend, second by Councilman Driver, to table consideration and approval of Resolution No. 2009-19, until Council has a clean copy of the current policy to compare with the redlined proposed changes to the policy. 9.4 David Kauffman presented an overview of the Engineered Pavement Management Plan and introduced Edwin Ridel of Claunch & Miller, who presented the Engineered Pavement Management Plan to Council. Claunch & Miller's recommendation is that City complete the worst streets over the next two years, then begin a scheduled replacement program the third year. Motion was made by Councilman Townsend, second by Councilman Webb, to accept the Presentation of the Engineered Pavement Management Plan by HDR/Claunch & Miller Engineering Consultants.

9.5 Lisa Coe presented an overview of employee health and welfare benefits. Randy Martell, IPS, provided information concerning the RFP bids for Project No. 2009-08. 9.8 David Kauffman presented information regarding the current waste disposal contract with Waste Management, Waste Management's refusal to extend the contract for the final extension period, and City staff's recommendations regarding the proposal received from Waste Management regarding the current agreement and actions to be taken. Motion was made by Councilman Driver, second by Councilman Webb, to authorize City staff to pursue requests for proposals for Solid Waste Removal and Disposal immediately.
