Motion was made by Councilman Lazenby to Adopt on First Reading, Ordinance No. 2009-11, an Ordinance Amending the Code of Ordinances of the City of Tomball, Texas, by Deleting Section 10-98 of Chapter 10 thereof, and Providing therefore a new Section 10-98 of Chapter 30, Establishing Restrictions that Shall Apply to All Livestock Kept Within the City, Exempting School District Property Utilizing Livestock for Educational Purposes; Providing a Penalty in an Amount not to Exceed \$2000 for each Day of Violation hereof; and Providing for Severability; and Making Other Provisions and Findings Related Thereto; second by Councilman Driver.

Motion was made by Councilman Harvey to table consideration of Item 9.1 pending the receipt of additional information, including the number of acres and the number of animals per acre, and notification of the surrounding property owners within 200 feet of the proposed facility; second by Councilman Driver.

Council received the City Manager's Vested Rights Determination Letter dated March 25, 2009, regarding Tomball Tomahawk Properties, LLC; no action was necessary.
