- 3.0 COUNCIL ENTERED INTO WORKSHOP TO DISCUSS THE FOLLOWING:
  - 3.1 FIRE PROTECTION SERVICES AND FIRE DISTRICT OPTIONS IN OUTLYING AREAS (OUTSIDE TOMBALL CITY LIMITS AND CITY'S EXTRA-TERRITORIAL JURISDICTION)

BEN GRIFFIN STATED THE VARIOUS OPTIONS AVAILABLE FOR FIRE PROTECTION AND INTRODUCED THE REPRESENTATIVES FROM HARRIS COUNTY.

MIKE MONTGOMERY ADVISED THAT HARRIS COUNTY, ROSEHILL ESD, KLEIN VFD, CY-FAIR VFD, AND SPRING VFD ARE WILLING TO FURNISH FIRE PROTECTION IN THE OUTLYING AREAS, IF NECESSARY. ROSEHILL ESD IS WILLING TO HANDLE FIRE PROTECTION ON A LONG-TERM BASIS

AND POSSIBLY INCORPORATE THE OUTLYING AREAS INTO THE ESD. HE ADVISED THAT SEVERAL CITIES ARE REQUESTING CHANGES IN FIRE PROTECTION AGREEMENTS DUE TO BUDGET CONSIDERATIONS.

JOANYE YOUNTS ADVISED THAT HARRIS COUNTY WILL BE CONSIDERING INCREASING FUNDS FOR THE NEW FISCAL YEAR; SHE WILL ADVISE RESULTS.

MIKE MONTGOMERY REQUESTED THAT CITY OF TOMBALL CONSIDER EXTENDING THE CURRENT INTERLOCAL AGREEMENT THROUGH SEPTEMBER 2004 IN ORDER TO HAVE SUFFICIENT TIME FOR AN ELECTION IN THE OUTLYING AREAS.
