- 3.0 New Business:
 - 3.1 The Public Hearing Regarding the Proposed Tax Increase Proposed 2007 Rate of \$0.251455/\$100 Assessed Value for the City of Tomball, Texas was opened by Mayor Fagan at 5:31 p.m.

Motion was made by Councilman Harvey to Adopt, on First Reading, Ordinance No. 2007-16, an Ordinance of the City of Tomball, Texas, Deleting Section 2-29 of the Code of Ordinances and Adding a New Section 2-29, Setting the Monthly Stipend for the Mayor and Monthly Compensation for the Mayor and Members of the City Council; Finding and Determining that the Meetings at which this Ordinance is Passed are Open to the Public as Required by Law; Providing for the Repeal of Ordinance No. 95-04, Adopted April 3, 1995, and the Repeal of all Other Inconsistent Ordinances; Providing for Severability; and Providing Other Matters Related to the Subject; second by Councilman Quinn.

The consensus of the council was to change Ordinance No. 2007-16 to read as follows:

Ordinance to be effective October 1 of each year to coincide with the budget and also be retroactive to October 1, 2007 for this year specifically. Change the suggested \$500 monthly stipend for Mayor to \$750 per month. Establish a monthly stipend for each Council member of \$200 per month. Both Mayor and each Council member are to receive \$100 per meeting in addition to the monthly stipends. Also, annually review for budget adjustments and index figures to the Bureau of Labor Statistics, Consumer Price Index for Houston or a similar index during the budget process. Motion was made by Councilman Harvey to adopt Ordinance No .2007-16, First Reading with changes as stated; second by Councilman Quinn:
