A GROUP OF BUSINESSMEN WISH TO HIRE AN ATTORNEY TO DEVELOP AN OIL AND GAS ORDINANCE TO ADDRESS THESE PROBLEMS; ONCE ORDINANCE HAS BEEN DRAFTED, IT WILL BE PRESENTED TO THE CITY FOR CONSIDERATION. MR.  - C. COUNCILMAN HOLLAND GAVE UPDATE ON CENTENNIAL COMMITTEE'S FIRST MEETING AND REQUESTED COUNCIL'S CONSIDERATION FOR FINANCING CENTENNIAL CELEBRATION ADVERTISING AND MARKETING THROUGH AN INCREASE IN THE HOTEL/MOTEL TAX.

- D. SHERRIE MATTSON PRESENTED UPDATE ON GAS PRICES; BEN GRIFFIN WILL CONTINUE TO MONITOR PRICES AND ADVISE COUNCIL IF IT BECOMES NECESSARY TO TAKE ACTION REGARDING UTILITY RATES
- E. KIT PFEIFFER PRESENTED TISD'S REQUEST FOR TWO RESOURCE OFFICERS. COUNCIL REQUESTED ADDITIONAL INFORMATION REGARDING TISD'S BUDGET AND STAFFING BEFORE MAKING A DECISION.

- F. MARK McCLURE PRESENTED UPDATE ON M-118 AND M-121 DRAINAGE PROGRESS; HE WILL RETURN TO COUNCIL IN NEAR FUTURE TO REQUEST FUNDING TO COMPLETE THESE TWO CHANNELS.
- G. ROY LACKEY PRESENTED REQUEST FROM M.U.D. #368 FOR AN EMERGENCY INTERCONNECT WITH THE CITY OF TOMBALL AT THE INTERSECTION OF BOUDREAUX ROAD AND SH 249.
- H. MARY COKER PRESENTED INFORMATION REGARDING REGULATION OF APARTMENT MAINTENANCE; CITY ATTORNEY ADVISES THAT CITY CAN ENFORCE NUISANCE AND BUILDING CODE VIOLATIONS, BUT NOT AESTHETIC VIOLATIONS.
- I. BEN GRIFFIN PRESENTED THE ISSUE OF REVISITING ZONING FOR THE CITY OF TOMBALL; CITY MAY REVISIT THIS ISSUE AGAIN IN THE FUTURE.
- J. MARK McCLURE PRESENTED THE NEED FOR AN OVERPASS AT MEDICAL COMPLEX DRIVE. TxDOT HAS REJECTED IDEA, SAYING THAT MEDICAL COMPLEX DRIVE IS TOO CLOSE TO FM 2920 TO BE ABLE TO INSTALL AN ADDITIONAL OVERPASS. MARK WILL TRY TO SET UP A MEETING WITH TxDOT TO DISCUSS POSSIBLE SOLUTIONS.
- K. GENE WHITENACK PRESENTED INFORMATION REGARDING RURAL FIRE PROTECTION DISTRICTS (RFPDs) AND EMERGENCY SERVICES DISTRICTS (ESDs); HE ADVISED THAT AN RFPD OR ESD TAXING AUTHORITY COULD BE CREATED TO SERVE THE ENTIRE 35 SQUARE MILES COMPRISING TOMBALL AND ITS SURROUNDING AREA OR AN RFPD OR ESD COULD BE ESTABLISHED TO SERVE ONLY THE 24 SQUARE MILES OUTSIDE TOMBALL AND TOMBALL WOULD BE REQUIRED TO SERVE ONLY ITS 10.5 SQUARE MILE AREA. IF AN RFPD WERE ESTABLISHED TO SERVE THE CITY AND THE SURROUNDING AREA, APPROXIMATELY \$420,000 PER YEAR WOULD BE REALIZED, AT \$0.05 TAXING RATE, TO OPERATE THE RFPD.
