I also understand that the program is not a seller, manufacturer, or dealer in smoke detectors.

In exchange for accepting the smoke detector, I agree not to make a claim or demand or to file any lawsuit against the City of Tomball, Tomball Fire Department, or their agents, affiliates, partners or representatives, for any injuries, damages, costs, or expenses claimed to have resulted from the Smoke Detector Program, the smoke detectors provided, the installation of the smoke detectors, or the failure or malfunctioning operation of the smoke detectors and I hereby release and discharge the City of Tomball, the Tomball Fire Department, their agents, affiliates, partners and representatives for any such claims. **IT IS MY INTENTION THAT THIS RELEASE SHALL EXTEND TO INJURIES AND/OR DAMAGES CAUSED BY THE TOMBALL FIRE DEPARTMENT, THEIR AGENTS, AFFILIATES, PARTNERS OR REPRESENTATIVES SOLE OR JOINT NEGLIGENCE, GROSS NEGLIGENCE, OR RECKLESS CONDUCT.** I further understand that for the smoke detector to be effective, I must replace the batteries on a regular basis (at least once per year) and that the batteries must be installed correctly.

This release from liability is binding on me and my family and all my heirs and successors.
