1. Application must be made at least one (1) month in advance but not more than twelve (12) months advance.
2. A \$75.00 fee per week is required at the time of application for hanging and removing banner. Applications are on a "first come-first served" basis.
3. The banner will be displayed in the 700 block of W. Main Street. Only one (1) banner will be displayed at a time. A banner may hang for a maximum of two (2) weeks.
4. The banner shall be picked up within one (1) week after expiration date. Owner will be assessed \$2.00/day storage fee if not picked up within the one (1) week period.
5. A TxDOT application for "Use of State of Texas Right-of-Way for Temporary Signs for Special Events" must be filled out and submitted along with City of Tomball reservation application and fees.

Allowable Displays

The following are banners permitted for display:

- Promotions for entertainment, recreational, educational, festival or sporting events sponsored by local non-profit community service organizations
- Promotions of fund raising events sponsored by local non-profit community service organizations
- Activities sponsored by the City of Tomball

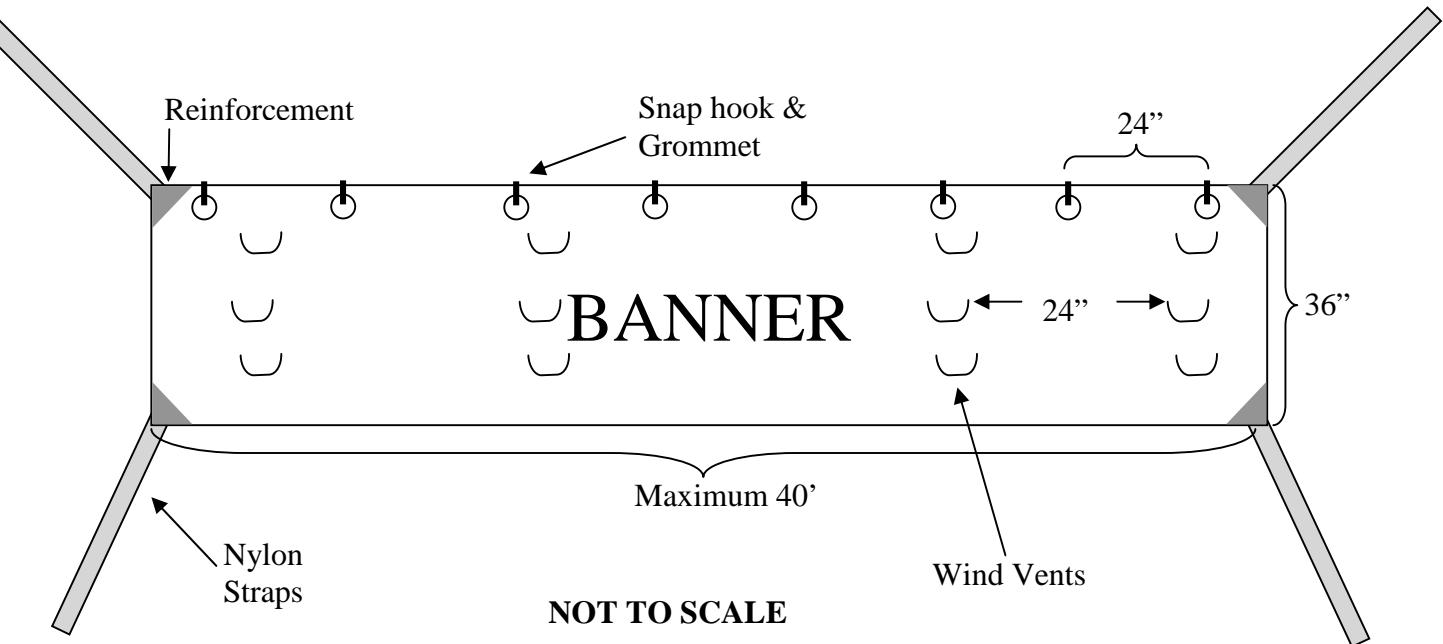

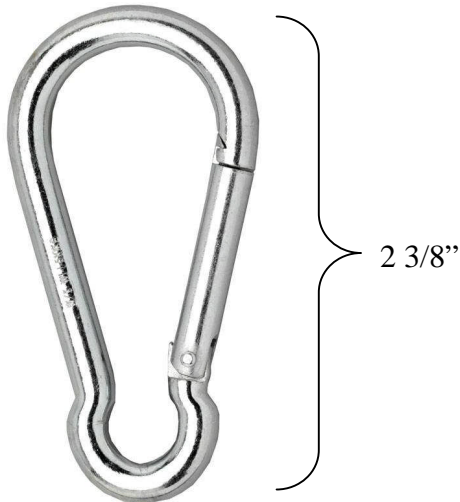

Banner Size & Configuration

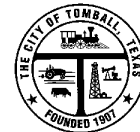
1. Holes in banner must have brass grommets 24" apart.
2. Banner must have wind vents every 24" apart.
3. Rope & banner must total no less than 70' top & bottom.
4. 3/8 nylon rope must be provided.
5. Snap hooks need to be in each top grommet. The snap hook must be 2 3/8".
6. It is recommended to have all corners reinforced.
7. Nylon straps must be 5' long, and 1" wide at all four corners.
