

JUNKED VEHICLE COMPLIANCE BOARD AGENDA

Code Administration will hold a public hearing on **Wednesday, September 30, 2009 at 11:30 a.m.**, in **City Council Chambers**, located at **1625 13th St.** The hearing will be held to consider disposition and appeals for junk vehicle cases, involving properties in the City of Lubbock. All interested persons may speak, and then the Board will make a decision on each case.

The Code Administration staff will present junked vehicle cases to the Junked Vehicle Compliance Board. Staff investigation indicates (1) that the vehicles in question are junked vehicles as defined in Section 16-368 of the Code of Ordinances of the City of Lubbock; (2) that the vehicles in question are not excepted from the provisions of Article XIII by Section 16-370 of the Code of Ordinances of the City of Lubbock; and (3) that the vehicles constitute public nuisances as set forth in Section 16-374 of the Code of Ordinances and must be abated.
