Purpose:

To allow a registered voter, who moves from one county to another, to vote during the early voting period or by mail.

Number of Copies Required:

Completed by:

The Voter.

Filing Date:

Same filing deadline as regular early voting in person and by mail. If voting in person, last day of early voting by personal appearance (not election day). If voting by mail, deadline for applying by mail.

Filed with:

Early Voting Clerk of the voter's new residence.

Comments:

As long as the voter was registered in his former county of residence when he moved, he is eligible to vote a limited ballot in the new county of residence. The early voting clerk in the new county of residence is not required to confirm the prior voter registration in the former county of residence. However, the early voting clerk must verify that the applicant does not have an effective registration in the county of new residence prior to providing a limited ballot. If the registration in the new county will be effective on or before election day, the early voting clerk shall reject the application for limited ballot, and have the voter vote in the regular manner, either during early voting in person or on election day.

Applicant must be a resident of the political subdivision or territory where offering to vote.

The applicant is not eligible to vote a limited ballot by mail unless, in addition to satisfying the eligibility requirements prescribed by Subsection (a), the person is eligible for early voting by mail under Chapter 82.

Voters do not have to apply for voter registration in their new county of residence prior to using this method of voting.

Completion of the limited ballot application will serve as a registration application for future elections in the county in which the application is submitted.

INSTRUCTIONS FOR APPLICATION FOR LIMITED BALLOT

INSTRUCTION NOTE TO EARLY VOTING CLERK: Section 112.005, Texas Election Code, provides that a voter who applies for a limited ballot by mail must submit BOTH an Application for a Limited Ballot and an Application for a Ballot by Mail. If a voter applies for a limited ballot by personal appearance, the completion of an Application for a Ballot by Mail is not required.

Section 112.002, Texas Election code, provides that a voter may only vote using this method if the voter was registered to vote in their previous county at the time they moved. Additionally, the voter is only entitled to vote for statewide offices, propositions, and each office and proposition stating a measure to be voted on in a territorial unit of which the person was a resident both before and after changing his or her county of residence.

*List of District Offices for which Voter is Entitled to Vote

*Section 112.008, Texas Election Code, requires the clerk to note on each voter's application a list of all offices and/or propositions for which he or she is permitted to vote.

(Refer to your district chart provided by the Secretary of State to assist you in determining for which district offices the voter is entitled to vote in primary and general elections.)

You must forward a copy to your county's voter registrar since this Application for a Limited Ballot will serve as a voter registration application. For purposes of voter registration, the effective date will be calculated as of the Election Date for which the Application for a Limited Ballot was submitted.
