I have enclosed for your use a corrected mail ballot. The original ballot mailed to you has been changed in a way that affects the choices of candidates for whom you may vote.

If you have not marked and mailed your original ballot, please destroy it and the carrier envelope provided to you for its return.

If you have already marked and mailed your original ballot, please mark and mail the corrected ballot. Your corrected ballot will be counted if it is received by the early voting clerk prior to 7:00 p.m. on election day. If you are voting from outside the United States, the late counting ballot rules may apply to you. Otherwise, your original ballot will be counted.
