Comments:

This is the individual form. This is one of several forms “combined” into the “combination form.” You do not need to fill out this individual form if you have filled out the appropriate spaces on the combination form.

- (1) If the voter offers to vote in the precinct listed on his certificate and the precinct number is wrong, the presiding judge sends the voter to the proper precinct.**
- (2) If the voter's residence is in the precinct where he is offering to vote, the presiding judge allows the voter to vote after completing the affidavit.**
- (3) The voter registrar should verify the records and issue the voter a corrected certificate.**
