Course Description

This course provides an introduction to theoretical approaches used in developing and implementing behavioral, social and cultural change to improve health for populations in specific settings. In addition, this course provides an overview of the behavioral and social factors that determine the health and wellness of individuals and communities. Health promotion and prevention programs designed to change social conditions and/or health behaviors should be based on social and behavioral theories and research. Health professionals and practitioners in various fields also apply social and behavioral theories and research to evaluate effectiveness of policies and programs. Students learn the importance of integrating multidisciplinary social, cultural, and political/economic perspectives to address health disparities and assess impacts of health policy.

Competencies Addressed

Upon completion of the course the student will be able to:

- Identify theories and methodologies from a range of social and behavioral disciplines used in the solution of public health problems that affect communities and individuals.
- Analyze social, cultural, political/economic and policy factors in health and disparities.
- Compare various community health promotion, assessment and planning models.
- Identify the components of successful community-based research design and implementation.

Course Requirements and Expectations

Exams: There will be two non-cumulative exams for this class.

Class Project:

Each student will apply social and/or behavioral theory to a contemporary public health problem, write and present a report to the class (about 5 pages double-spaced, with 4-5 references cited and listed at end under "References"). The report is to follow this format:

- **1.Health problem and background:** Select a health priority area from special topics (Coriel text, chapters 17-20) and summarize recent national health research in that area.
- 2. Community epidemiology: Describe the general health and social needs of a local community group.
- **3. Application of theory:** Describe how social or behavioral theory can be applied to understand and address the major environmental, social, cultural, occupational, and/or individual factors that affect health in this group.
