Davis-Bacon Act (New): Recipients shall obtain and maintain in its official records documentation of weekly certified payroll reports and the Statement of Compliance from itself and all sub-recipients, contractors, and subcontractor(s) in accordance with Section 1606 of the American Recovery and Reinvestment Act of 2009 and the Davis-Bacon Act and related acts. This SAC is informational with no specific due date.

For-Profit Recipient Audit Requirement (Revised): A for-profit organization receiving a BTOP award exceeding \$100,000 in Federal funding shall have a program-specific audit performed based on the recipient's BTOP program year, beginning with the date of the issuance of the BTOP award. Please check your individual amendment for due date.

Environmental Assessment (Revised): The allowable use of funds for limited, preliminary procurements prior to beginning project implementation includes, but is not limited to, the initiation of activities necessary to meet the project completion requirements as specified in the award. To take advantage of this change, please submit an expenditure plan within 10 days of receipt of this SAC.
