

Tips on how to access EFS-Web on the new website.

- On the USPTO home page, from the Patents column, select the third option, “File Online.”

- 1 **Search**
Search the Patent Full-Text and Image Database (PatFT)
- 2 **View Fee Schedule**
Check on the current fees and information related to the patent process
- 3 **File Online**
Apply for a patent application using the Electronic Filing System (EFS-Web)
- 4 **Check Status**
Check the status via the Patent Application Information Retrieval (PAIR) system

- This will bring you to the “About EFS-Web” page. Selecting the hyperlink to either EFS-Web Registered or Unregistered eFiler will launch the respective system.

About EFS-Web

EFS-Web is the United States Patent and Trademark Office’s (USPTO’s) web-based patent application and document submission solution. Using EFS-Web, anyone with a web-enabled computer can file patent applications and documents without downloading special software or changing document preparation tools and processes.

EFS-Web utilizes standard web-based screens and prompts to enable you to submit patent application documents in PDF format directly to the USPTO within minutes. When creating your PDF documents, you choose the tool, process and workflow with which you author your documents; convert them to standard PDF files and then submit them to USPTO’s secure servers. Additionally, EFS-Web allows submission of *PCT-EASY*.ZIP compressed files to submit International PCT applications and ASCII text files (.TXT) to submit your bio-sequence listings, computer program listings, mega tables, etc. EFS-Web is safe, simple and provides you all of the same benefits as paper filings, including an electronic receipt that acknowledges your submission.

- Launch EFS-Web Registered eFiler - for enhanced filing, follow-on processing, saved submissions
- Launch EFS-Web Unregistered eFiler - for Basic initial filing of patents
- EFS-Web Announcements - recent and archived announcements, links to view availability of business alerts
- EFS-Web Resources - instructions for becoming a Registered eFiler, system requirements, EFS-Web other useful information and links

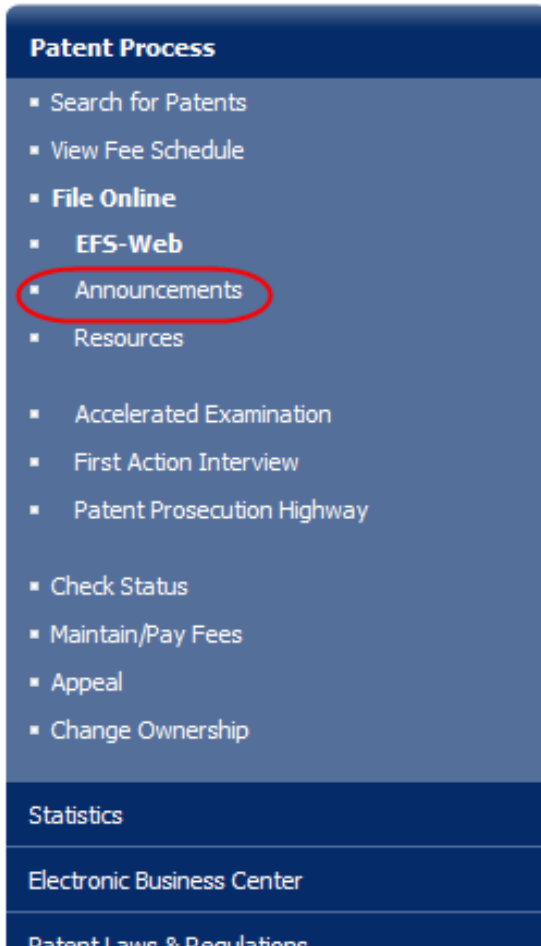

EFS-Web Guidance and Resources

Benefits of using the Electronic Filing System (EFS-Web)

- **EFS-Web is safe.** Filings made with EFS-Web provide you with the same legal protection as paper-based filings. You receive an electronic receipt and confirmation, as well as the ability to print the receipt for your records, affirming your receipt date.
- **EFS-Web is simple.** Even the largest and most complex patent applications can be submitted by attaching PDF files and filling out a few simple web screens.
- **EFS-Web is secure.** EFS-Web submissions are protected through state-of-the-art security methods, including Transport Layer Security (TLS), and if you sign up as a registered filer, Digital Certificates, one of the most secure methods now available.
- **EFS-Web is fast.** In just a few minutes and using a few web screens, you can submit a filing and receive an acknowledgment receipt.
- **EFS-Web is flexible.** EFS-Web requires you to make no changes to the tools, processes, patent applications and documents. Filing with EFS-Web does not require you to learn how to use a new system.
- **EFS-Web is forgiving.** EFS-Web validates whether the PDF files and data you're trying to submit are correct before they are submitted. If there's a problem, EFS-Web will tell you why the document can't be submitted and allow you to take corrective action quickly.
