Center is beginning to see an influx of interest in the Caregiver field. The grant received from the Arizona Governor's Workforce Council has allowed 20 applicants to move through the training process with their sights sets on local in-demand jobs.

These opportunities introduce real work experience for 16-21 year olds. In addition

During their training period, Bearizona was not yet open to the public, which allowed both to be employed from the ground up!

In late May Bearizona opened to the public, Jocelyn and Gilbert were both integral team members in getting the park ready for its opening day. Since opening, Bearizona has received many inquires from the public and media to which Jocelyn responds. Jocelyn provided

Youth Works 2010

#### This summer the Coconino County *Youth Works 2010* crew has been participating in beautification projects throughout the Greater Flagstaff area. The crew is employed through the Summer Youth Employment Program sponsored by the Coconino County Board of Supervisors from federal Workforce Investment Act and ARRA funds. Local youth, ages 16-20, were employed in this five week program.

Throughout the summer the crew was kept busy working at

- Museum of Northern Arizona
- Flagstaff Housing Authority
- Lowell Observatory
- North County Health Care
- Coconino County Admin Bldg
- Highlands Fire Department
- Second Chance Animal Shelter
- Leupp Chapter House on the

#### Navajo Nation.

These projects have included work such as invasive plant removal, trash removal, fire management, trail building, stacking logs to be used for heating elderly community members' homes in the winter, and washing a fire truck. Other tasks involved were painting picnic tables, playground sets, handicap/no parking curbs, and benches. Through these activities, the participants have grown into a cohesive group learning skills such as team building, responsibility, and punctuality. Each member has displayed their individual talents and integrated those into the group dynamic that has kept this crew going strong and working through the challenges they faced this summer.

In addition to career opportunities and experiences, the crew has had many educational experiences and teachable moments throughout the summer. Certified teacher, Ms. Betsy Bale not only supervised the crew out in the community on their work projects but also found many ways to provide the teaching moments.

They were shown the Museum of Northern Arizona by a docent as well as allowed to take a private look inside their new LEED award winning Easton Collections Center. At Lowell Observatory, the crew was able to look at the sun through the solar telescope and participate in a tour to learn about the amazing explorations that have taken place on the grounds. At Highlands Fire Department, the crew received a refresher course on First Aid/CPR and an introduction to use of thermal cameras in a structural fire.

Fire awareness and management have been a reoccurring theme throughout the *Youth Works 2010* program. When the Schultz fire erupted participants witnessed smoke plumes on the mountain and helicopters picking up water from tankers, the crew helped in fire management and prevention by clearing pine needles from the landscapes and firefighter 'Blue' spoke with the crew about the causes of two main fires in town this season encouraging the use of safe campfire practices.

Coconino County and the Flagstaff community are thankful for the hard work and positive role modeling from the *Youth Works 2010* crew members. This program has been a valuable experience for youth who are actively looking and applying for post summer jobs. Each participant has completed an updated resume to be used during their job search. *Youth Works 2010* encourages teen employment and builds career skills for a brighter workforce of tomorrow.

## Coconino Career Center: Providing a Bridge to the Future

The American Recovery and Reinvestment Act of 2009 was signed into law by President Obama on February 17, 2009. The Recovery Act is intended to preserve and create jobs, promote the nation's economic recovery and assist those most impacted by the recession.

Coconino County was awarded \$586,641 for activities authorized under the Workforce Investment Act (WIA) which is being administered by the Coconino County Career Center. The Coconino County Career Center mission is:

To provide a bridge to the future, making a difference by:

- Training individuals to take charge of their career success
- · Providing employers with quality employees
- Meeting the challenge of a changing work environment


We conscientiously serve the communities of our county and positively contribute to a better economy.


The Career Center is focusing strongly on:

- Adult programs including adult training and employment.







Adults / DW's Entering & Exiting the Program
