Excerpt: "It's not about what you did somewhere else," said Justin Jones, a trainer at Maricopa Workforce Connections, part of the Maricopa County Department of Human Services. "It's about what you can do, specifically, for them." ... "Hiring managers all want someone who will lower costs, boost revenue, save time, and attract and retain customers, Jones said.' The answer to nearly every question should speak to one of those specific issues, he said. 'When an employer says, 'Tell me about yourself,' what they're really saying is, 'Tell me what you can do for me,' he said."

The curse of status anxiety. Don't let your job—or lack of one—wreck your mental health

By Rosa Cays, February *Latino Perspectives Magazine*Excerpt: "I'm supposed to be the man of the house," says Herrera, whose wife Lupita

doesn't necessarily see it that way; she's encouraged Herrera to "not let it get to him." At the age of 40, he's going back to school to take classes in criminal justice, veering his career 180 degrees. Now Lupita's working full time, switching roles with Herrera as the active provider for their family. It was their intention when they first married that Herrera would work while Lupita went to school, then they would trade places; they didn't expect it to be forced on them by economic need.

Herrera is grateful to have the moral support of his wife and four sons. He's been on a psychological rollercoaster ride, enduring sleepless nights, bouts of anxiety and despondency. He says that it's really helped him to be able to talk about his frustrations. "It's been rough, but I'm determined," says Herrera, "and hopeful." (Mr. Herrera is a MWC customer.)

The stimulus: One year later Is it working?

Excerpt: "Maricopa County has not had a summer program in years," Burkhart says. "We're using some of the stimulus funds to serve an additional 200 clients over our normal year-round program. We will have sufficient funds in the youth program left over to do a summer youth experience next summer. It will be several hundred, so that's an enormous benefit.

"A lot of jobs that have disappeared in this recession probably will not come back," Burkhart asserts. "One-third of the jobs lost in the state were construction jobs. A lot of that talent needs to be repositioned so we can have a workforce prepared for whatever a recovered economy is going to look like. That means people are going to need higher levels of skills if we're going to be competitive in the national and international economy."



"The recession also has dramatically increased MWC's job placement client visits to 14,000 per month, so the additional funding helped the organization absorb increased operating costs as well as add four new staff positions."
