Employment and Training Administration (ETA)

The Employment and Training Administration (ETA) is currently reviewing applications from Oregon, Maine and Delaware for of UI Modernization Funds.

Tennessee enacted a retroactive Total Unemployment Rate (TUR) trigger in its Extended Benefits (EB) law and, effective April 12, 2009, Tennessee exceeded the TUR threshold for a high unemployment period, making up to 20 weeks of EB available to eligible claimants.

Tennessee was approved for its share of the \$7 billion Unemployment Insurance Modernization special distribution. ETA notified the Department of Treasury to transfer the UI Modernization funds of about \$142 million into the Tennessee State Account.

The Iowa Workforce Development submitted a dual enrollment application for \$335,853 in Workforce Investment Act (WIA), Title I, Section 173, National Emergency Grant (NEG) funds, which was received on May 15, 2009. ETA is recommending that the application be approved for \$335,853, and be funded by resources made available for NEGs under the American Recovery and Reinvestment Act (ARRA) of 2009. The purpose of the request is to serve approximately 125 of the 290 workers affected by the closure of Atwood Mobile Products (formerly Dura) in West Union, Iowa. All workers have been certified as eligible for Trade Adjustment Assistance (TAA).

Illinois has enacted the TUR trigger and exceeded the TUR threshold for a high unemployment period beginning May 3, 2009; as a result, eligible claimants may receive up to 20 weeks of extended benefits. Illinois earlier triggered "on" to a 13-week EB period beginning April 5, 2009, based on meeting the Insured Unemployment Rate (UIR) threshold.

Employee Benefits Security Administration (EBSA)

EBSA continues to respond to over 700 COBRA inquiries on a daily basis. There have been almost 104,000 since the enactment of the ARRA.

EBSA now has over 36,200 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with over 1,405,000 total visitors since enactment of the ARRA.

EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing, with the cumulative total reaching over 4,996.

Office of Job Corps

Major Planned Actions (Short bulleted list of the major planned actions)

On Friday July 9, The Vice President is announcing \$275 million for New York in UI Modernization Funds. Also ready for announcement are \$141 million to Tennessee and \$59 million to Arkansas .

During the week of July 13, 2009, Arkansas will be notified of approval of its full share of the \$7 billion UI Modernization special distribution/incentive payments. As of July 6, 2009, \$1,669,592,696 has been distributed to a total of 26 states for UI Modernization incentive payments.

Webinars for prospective grant applicants will be held July 13-14 for two of the five Green Jobs grant solicitations: 1) Energy Training Partnership Grants, and 2) Pathways out of Poverty Grants. These webinars provide overviews of each grant solicitation and responses to questions.

ETA continues to finalize the release of several Recovery Act-related Training and Employment Guidance Letters (TEGLs), including those regarding: Providing draft Health Coverage Tax Credit National Emergency Grant TEGL to Stimulus Team for funds made available by the Recovery Act; Recipient Reporting Requirements under Section 1512 of the Recovery Act; Information and Guidance on the Two New Work Opportunity Tax Credit (WOTC) Targeted Groups Introduced by the Recovery Act; TEGL 22-08, Change 1, on the TAA Operating Instructions, including a series of Questions and Answers; Guidance to designate certifying officers to carry out functions under the TAA program; and Reporting Guidance and Instructions for the Workforce Investment Act, Section 166, Indian and Native American Supplemental Youth Service Program including performance accountability reporting for the Recovery Act.
