## Financial and Activity Report (sheet 2 of 2)

### Major Completed Actions (Short bulleted list of the major actions taken to date.)

#### Employment and Training Administration (ETA)

As of July 31, 2009, \$2.3 billion has been distributed to a total of 30 states for UI Modernization incentive payments. ETA is reviewing Wisconsin's and Montana's applications for their remaining 2/3rds share of UI Modernization incentive payments.

New Hampshire has triggered "on" to Extended Benefits (EB) based on its Total Unemployment Rate (TUR) trigger. Eligible claimants will be able to collect up to an additional 13 weeks of UI benefits.

Texas has enacted a law adding a TUR trigger to the state's EB law retroactive to February 1, 2009. As a result, Texas has triggered "on" to an EB period for weeks of unemployment beginning May 3, 2009. Eligible claimants will be able to collect up to an additional 13 weeks of UI benefits. Notices of the change in these states' EB status are expected to be published in the Federal Register the week of August 10.

Arizona, Delaware and New York triggered "on" to a High Unemployment Period within the EB program and eligible claimants will be able to collect up to 20 weeks of additional benefits.

ETA's deadline for submitting applications for the first Green Jobs Solicitation for Applications (SGA) on Green Capacity Building under the Recovery Act was August 5, 2009.

ETA continues to process the 1,581 petitions that have been filed since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. 317 determinations have been made on cases filed under the new law. ETA is also providing training to State and Regional staff on petition processing and for program and policy functions, developing new reporting and Web requirements by the statutory deadline of August 17, and revising state reports.

ETA is working to comply with Office of Management and Budget guidance on Recovery Act reporting requirements, per Section 1512 of the Act, including efforts to disseminate guidance to the workforce system, develop a data quality review process required by Federal agencies, and provide technical assistance and training for grantees and Federal staff. The initial planning has taken place and offices responsible for various activities have taken the lead on coordinating those activities.

ETA is compiling a weekly report, entitled the *Summer Youth Snapshot*, which provides highlights of Recovery Act-funded activities specific to the Summer Youth Employment Program from various program locations across the nation. Summer Youth Employment Program site visits, monitoring and technical assistance efforts conducted by ETA Regional Office representatives are ongoing through the end of September 2009.

**Office of Recovery for Auto Communities and Workers (ORACW)**

On Wednesday, August 5, 2009, Dr. Ed Montgomery, the Executive Director of the White House Council on Automotive Communities and Workers, traveled to Traverse City, MI to be a presenter at the 2009 Center for Automotive Research (CAR) Management Briefing Seminar. Many community leaders took part in this meeting which focused on the economic development and recovery issues facing automotive communities. Attendance at CAR's Management Briefing Seminar included the participation of Akio Toyoda of the Toyota Motor Corporation.

**Employee Benefits Security Administration (EBSA)**

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been almost 115,000 since the enactment of the ARRA.

EBSA now has over 38,000 subscribers to [www.dol.gov/cobra](http://www.dol.gov/cobra) who will receive automatic notices of new or updated COBRA announcements with over 1,525,000 total visitors since enactment of the ARRA.

EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 6,922.

**Employment Standards Administration (ESA)**

The Wage & Hour Division of ESA is working with the Department of Energy to collect their completed 308s, the document required of federal agencies to request a project based wage determination, so that DOL can begin to issue weatherization classifications and rates within the coming week for the states of Michigan, California, New York, Maine and New Hampshire.



**Major Planned Actions (Short bulleted list of the major planned actions)**

The Employment & Training Administration is reviewing three National Emergency Grant (NEG) awards. Those that are approved may be announced as early as next week, and the following would be funded by resources made available by the Recovery Act: Iowa – \$521,910 to assist workers affected by layoffs at Featherlite Trailers, Inc. in Cresco, Iowa; Wisconsin – \$3,421,645 to assist workers laid off by manufacturing companies in northeastern Wisconsin. \$1,667,740 will be released initially; North Carolina – \$2,000,000 for a Health Coverage Tax Credit “gap filler” NEG.

ETA continues to finalize the release of several Recovery Act-related Training and Employment Guidance Letters (TEGLs) including those regarding: Recipient Reporting Requirements under Section 1512 of the Recovery Act; Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act; Information and Guidance on the Two New Work Opportunity Tax Credit (WOTC) Targeted Groups Introduced by the Recovery Act; TEGL 22-08, Change 1, on the Trade Adjustment Assistance (TAA) Operating Instructions, including a series of Questions and Answers; Guidance to designate certifying officers to carry out functions under the TAA program; and Reporting Guidance and Instructions for the Workforce Investment Act, Section 166, Indian and Native American Supplemental Youth Service Program including performance accountability reporting for the Recovery Act.
