As of August 21, 2009, \$2.3 billion has been distributed to a total of 30 states for UI Modernization incentive payments. The Employment Training Administration (ETA) is reviewing applications from Colorado and West Virginia for their 1/3 shares and from Illinois, New Hampshire and Wisconsin for their remaining 2/3rds shares of UI Modernization incentive payments.	ETA staff will participate in reviews of the Emergency Unemployment Compensation and the Federal Additional Compensation programs in Florida, Indiana and California during the week of August 24, 2009.
The Virgin Islands met the threshold for a high unemployment period and will trigger "on" to the second tier of Emergency Unemployment Compensation benefits beginning August 23, 2009.	A Wisconsin Unemployment Insurance press call is being scheduled for either August 25 or August 27 with Secretary Solis, Senator Kohl, Senator Feingold, and Governor Doyle.
On August 19, 2009, ETA held a webinar for grantees receiving Recovery Act funds on the recipient reporting requirements in section 1512 of the Act. ETA staff met with officials from Johns Hopkins University for an update on skills training projects and demonstrations related to green jobs, health care, and community-based training programs. The State Recovery Act Readiness Reviews Report has been finalized and includes suggestions for areas needing technical assistance. Offices are reviewing the report and making recommendations for revisions to the previously completed Recovery Act Risk Management Plans based on these suggestions.	
ETA continues to process 1,650 petitions that have been filed since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act took effect on May 18, 2009. 474 determinations have been made on cases filed under the new law. ETA is also providing training to State and Regional staff on petition processing and on program and policy functions, developing new reporting and Web requirements, and revising state reports.	
ETA has undertaken an outreach strategy to recruit panelists to review Recovery Act grant applications. A letter from Assistant Secretary Jane Oates will be sent to her federal counterparts at Environmental Protection Agency, National Science Foundation, the Small Business Administration, and the Departments of Agriculture, Commerce, Education, Energy, Health and Human Services, and Housing and Urban Development to request panelists for grant review. EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 7,803.	
<b>Employment Standards Administration (ESA)</b>	
Weatherization rates for Arkansas, Connecticut, District of Columbia, Iowa, Maine, Massachusetts, Michigan, Nebraska, New Hampshire, New Jersey, Rhode Island, and Utah have been published and are posted on the ARRA web site. The remaining will follow.	
According to the Federal Transit Administration, the OLMS has issued close to all certifications associated with the first round of ARRA funding.
