As of August 21, 2009, \$2.3 billion has been distributed to a total of 30 states for UI Modernization incentive payments. Idaho will trigger "on" to a High Unemployment Period. Beginning September 6, eligible claimants will be able to collect up to an additional 20 weeks of benefits.
