## **Financial and Activity Report (sheet 2 of 2)**

### **Major Completed Actions (Short bulleted list of the major actions taken to date.)**

#### **Employment and Training Administration (ETA)**

As of September 18, \$2.6 billion has been distributed to a total of 32 states for UI Modernization incentive payments. There are no state applications pending approval for UI Modernization incentive payments at this time.

Recovery Act monthly participant data for the month of August was due on September 15, and publishable data from this report will be available September 30.

ETA convened the Recovery and Reemployment Research Conference on September 15-16 in Washington, DC. The conference was designed to translate research into practice, and explored past and present research examining the delivery of reemployment services throughout the public workforce system, the linkages between unemployment insurance and the employment service, and effective strategies to best serve unemployed workers. Over 350 participants attended the conference.

On September 18, ETA hosted a live webinar for the ETA grantee community on Recovery Act Section 1512 Recipient Reporting requirements. Also, a live webinar for ETA Federal Project Officers was held on September 14 focusing on registration of recipients and sub-recipients and the data quality review process.

On September 15, ETA issued Training and Employment Guidance Letter No. 6-09, "Instructions for Implementing the Revised 2010 Trade Adjustment Assistance Trade Activity Participant Report (TAPR)."

ETA continues to see an increase in the number of trade petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18 due to the recession, continued layoffs as a result of foreign trade, and the re-filing of petitions resulting from the 2009 Amendments. As of September 18, 819 determinations had been made on cases filed under the new law.

#### **Employee Benefits Security Administration (EBSA)**

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been almost 131,500 since the enactment of the ARRA.

EBSA now has over 40,700 subscribers to [www.dol.gov/cobra](http://www.dol.gov/cobra) who will receive automatic notices of new or updated COBRA announcements with over 1,685,000 total visitors since enactment of the ARRA.



**Major Planned Actions (Short bulleted list of the major planned actions)**

ETA Regional Offices have been conducting state oversight reviews of the Emergency Unemployment Compensation (EUC) and the Federal Additional Compensation (FAC) programs throughout the summer and plan to continue monitoring visits through September 2010. The program review state site visits are intended to ensure accurate implementation of the EUC and FAC programs. ETA staff participated in oversight reviews in Pennsylvania and Michigan during the week of September 14, and in Virginia and Wyoming during the week of September 21.

ETA continues to finalize the release of several Recovery Act-related Advisories: TEN on Intent to Change Reporting Requirements for the Workforce Investment Act Standardized Record Data; TEGL on the Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act; TEGL No. 22-08, Change 1, on the Trade Adjustment Assistance Operating Instructions, including a series of Questions and Answers; and TEGL No. 1-09, Change 1, Reporting Requirements under Section 1512 of the American Recovery and Reinvestment Act of 2009.

On September 17, DOL announced a \$323,565 National Emergency Grant (NEG) to assist workers affected by layoffs at NewPage Corp.'s Rumford Paper Mill in Rumford, Maine. This grant will be funded by resources made available for NEG's under the Recovery Act.
