Employment and Training Administration (ETA)	
As of November 6, \$2.8 billion has been distributed to a total of 32 states for Unemployment Insurance (UI) Modernization incentive payments. On November 4, Massachusetts was approved for \$108 million in UI modernization incentive funds. No applications for UI Modernization funds are pending at this time.	On November 2, the U.S. Department of Labor awarded a National Emergency Grant (NEG) for \$827,616, with funds made available under the Recovery Act, to assist about 135 workers in the commonwealth of Massachusetts affected by the closure of Jabil Circuit Inc. in Billerica, MA. Awarded to the Massachusetts Department of Workforce Development, the grant will be operated by the Career Center of Lowell. The NEG will provide these dislocated workers, all of whom are also certified as eligible for TAA, with access to "wrap-around" and supportive services, such as dependent care and transportation assistance, which are not available through the TAA program.
ETA conducted an oversight review of the Emergency Unemployment Compensation (EUC) and the Federal Additional Compensation (FAC) programs in Maryland and Puerto Rico during the week of November 2.	ETA continues to finalize the release of several Recovery Act-related advisories: TEGL No. 22-08, Change 1, on the Trade Adjustment Assistance Operating Instructions, including a series of Questions and Answers; TEGL on the Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act; and TEN on Intent to Change Reporting Requirements for the Workforce Investment Act Standardized Record Data.
Texas and Connecticut met the 8.0% threshold to trigger "on" to a high unemployment period in the EB program, beginning November 8. Minnesota will trigger "off" a high unemployment period, as of the week ending November 14.	
ETA provided technical assistance and participated in four conference calls with various officials in South Carolina to assist them in drafting legislative language to retroactively trigger "on" to Extended Benefits (EB). The legislation was enacted on October 28. The retroactive trigger restores the EB period in South Carolina allowing for prior EB exhaustees to be eligible for up to 7 additional weeks of benefits. Current and prospective EB beneficiaries may be eligible for up to 20 weeks of benefits.	
As of the end of September 2009, 306,466 youth have participated in summer employment through the WIA Youth program and the Indian and Native American Supplemental Youth Services Program; 1,994,918 individuals have received Wagner-Peyser reemployment services; and 4,265 individuals have received training and supportive services through Recovery Act-funded National Emergency Grants.	
ETA continues to work to complete determinations for petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. As of November 6, there have been 1,422 determinations made on cases filed under the new law.	
Employee Benefits Security Administration (EBSA)	
EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been almost 149,500 since the enactment of the ARRA.	
EBSA now has over 44,000 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with over 1,865,000 total visitors since enactment of the ARRA.	
EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 11,609.	
Office of Recovery for Auto Communities and Workers	
On November 2, Dr. Montgomery, the Executive Director of the White House Council on Auto Communities and Workers and Director of the Office of Recovery for Auto Communities and Workers, led the fourth meeting of the "Cities in Transition" working group. This is a spin-off group from the White House Office of Urban Affairs, the NEC and the DPC's cross-agency policy development process focused on place-based initiatives. This group will focus on addressing the special needs of cities in transition, roughly defined as communities that will still be grappling with high unemployment and other issues when the recession ends, as a result of structural changes in their economies in recent years. This will be a recurring meeting every Monday.	
On November 3, Dr. Montgomery traveled to Orlando, Florida to participate in the 2009 Defense Community Conference, "Partnering for Success". The invitation only conference included approximately 1000+ state and local officials, installation commanders and their representatives, the cognizant Federal Agencies, and other stakeholders from military communities and installations. Ed served as the keynote speaker, discussing the Administration's focus and commitment to partner with auto-impacted states, communities, businesses, and workers to provide place-based Federal assistance under the guidance of the White House Council for Automotive Communities and Workers.	
Office of the Inspector General (OIG)
