As of November 13, 2009, \$2.8 billion has been distributed to a total of 32 states for Unemployment Insurance (UI) Modernization incentive payments. No applications for UI Modernization funds are pending at this time.	ETA staff will conduct oversight reviews of the Emergency Unemployment Compensation (EUC) and the Federal Additional Compensation (FAC) programs in Arizona, New York, and Tennessee during the week of November 16, 2009.
Texas and Connecticut met the 8.0% threshold to trigger “on” to a High Unemployment Period (HUP) in the Extended Benefits program, beginning November 8, 2009. Utah met the 6% TUR threshold to trigger “on” to the Third Tier of EUC, beginning the week of November 8, 2009. Minnesota will trigger “off” a HUP, as of the week ending November 14, 2009.	On November 16, 2009, ETA program and grants management staff will conduct orientation sessions for reviewers of the applications submitted for the Pathways Out-of-Poverty grant solicitation (SGA/DFA PY-08-19) and the State Energy Sector Partnership and Training grant solicitation (SGA/DFA PY-08-20). These grant solicitations are part of the \$500 million allocated by the Recovery Act for competitive grant investments in green jobs training.
On November 9, 2009, the U.S. Department of Labor announced a \$394,617 grant to assist about 60 workers affected by layoffs at The Hinckley Co., a leading producer of pleasure boats and yachts, in Trenton, Maine. Awarded to the Maine Department of Labor, this grant will be operated by the Eastern Maine Development Corp. The grant will provide affected workers with access to dislocated worker services including individualized career assessments and planning services, recruitment, case management, job skills training, basic computer skills training and job placement. This grant will be funded by resources made available for National Emergency Grants under the American Recovery and Reinvestment Act of 2009.	Two <i>Recovering America's Youth Summits</i> will be held in Chicago, IL, on November 17-19 and Dallas, TX on December 1-2. The summits will focus primarily on three areas: 1) findings and lessons learned from the Recovery Act summer youth employment program; 2) building the capacity of state and local areas to serve older out-of-school youth, ages 18-24, in year-round activities; and 3) the integration of strategies to develop training and employment opportunities for youth in renewable energy and energy-efficiency industries.
On November 6, 2009, President Obama signed the Worker, Homeownership, and Business Assistance Act of 2009. The law expands the Emergency Unemployment Compensation (EUC) program for weeks of unemployment beginning on November 8, 2009, or later, and: Makes Tier II EUC available in <u>all</u> states and increases benefits from 13 weeks to 14 weeks; Creates a new Tier III EUC which will be available in states with a three-month average total unemployment rate (TUR) of 6.0% or higher, or a 13-week insured unemployment rate (IUR) of 4.0% or higher – the same levels of unemployment previously required for Tier II EUC. Tier III provides up to 13 weeks of benefits; Creates a new Tier IV EUC which will be available in states with a three-month average TUR of 8.5% or higher, or a 13-week IUR of 6.0% or higher. Tier IV provides up to 6 weeks of benefits; and This Act does <u>not</u> change the expiration date of the EUC program (December 31, 2009) or the end of the phase-out period for current EUC beneficiaries (May 31, 2010).	ETA continues to finalize the release of several Recovery Act-related advisories: Unemployment Insurance Program Letter (UIPL) No. 23-08, Change 5 to provide guidance to the states on the provisions of the new law expanding the Emergency Unemployment Compensation program; UIPL No. 14-09, Change 3, Special Transfers for Unemployment Compensation Modernization and Administration and Relief from Interest on Advances; Training and Employment Notice (TEN) to One-Stop Centers and Others Concerning COBRA Premium Reduction and Extended Eligibility Provisions; TEN on Intent to Change Reporting Requirements for the Workforce Investment Act Standardized Record Data; Training and Employment Guidance Letter (TEGL) No. 22-08, Change 1, on the Trade Adjustment Assistance Operating Instructions, including a series of Questions and Answers; and TEGL on the Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act (National Emergency Grant policy guidance).
The Departmental Office of Inspector General’s (OIG) audit entitled <i>Recovery Act: Performance Reporting Creates Challenges for the Department of Labor</i> (09/2/2009), recommended better alignment between the Program-Specific Recovery Plans and Recovery Act Risk Mitigation Plans. ETA is revising its Program-Specific Recovery plans to incorporate performance measures that reflect the agency’s program-specific risk mitigation strategies and is developing quantitative measures of the “triggers” that would activate the risk mitigation process.	
ETA continues to work quickly to complete determinations for petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. As of November 13, there have been 1,478 determinations made on cases filed under the new law.	
Employee Benefits Security Administration (EBSA)	
EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been almost 151,000 since the enactment of the ARRA.	
EBSA now has over 45,000 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with over 1,895,000 total visitors since enactment of the ARRA.	
EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 11,881.	
Office of Recovery for Auto Communities and Workers	
On November 9, Dr. Montgomery, the Executive Director of the White House Council on Auto Communities and Workers and Director of the Office of Recovery for Auto Communities and Workers, led the fifth meeting of the “Cities in Transition” working group. This is a spin-off group from the White House Office of Urban Affairs, the NEC and the DPC’s cross-agency policy development process focused on place-based initiatives. This group will focus on addressing the special needs of cities in transition, roughly defined as communities that will still be grappling with high unemployment and other issues when the recession ends, as a result of structural changes in their economies in recent years. This will be a recurring meeting every Monday.	
On November 10, Dr. Montgomery and his staff convened a meeting with representatives of the Treasury Department’s Recovery Zone Bond program and Senator Sherrod Brown’s office to discuss how they could be used to redevelop the former DHL air park in Wilmington, OH. Staff also participated in a broader discussion about increasing uptake of the bonds in OH and other states, and will be working with the State and Treasury on a future outreach strategy.	

<p>On November 13, Dr. Montgomery traveled to participate in a community forum with community leaders from Northern California in response to the upcoming closure of the New United Motor Manufacturing Inc. (NUMMI) plant in Fremont, CA. The plant is expected to close in March 2010, laying off 5,000 workers. Local leaders reached out to Dr. Montgomery and invited him to travel to the area and meet with local leaders, using the model of previous trips to Michigan, Ohio and Missouri. The Office of Recovery for Auto Communities and Workers had been planning this trip in conjunction with staff from the following Congressional Leaders: Senator Feinstein, Senator Boxer, Congressman Stark, Congressman McNerney and Congresswoman Lee, along with local leaders from the affected cities and county. Dr. Montgomery led a team of representatives from agencies that are members of the White House Council for Automotive Communities and Workers. They received testimony from local leaders and learned about the situation on the ground and Dr. Montgomery lead a discussion between the community and the federal agencies about what resources/programs are available to the community to help them through the transition.</p>
