In accordance with the TAA amendments mandated as part of the Recovery Act, the NPRM proposes regulations addressing how the Department distributes TAA training funds to the States that administer the program. The notice also proposes that personnel engaged in TAA-funded functions undertaken to carry out the worker adjustment assistance provisions must be State employees covered by the merit system of personnel administration, applicable to personnel engaged in employment security administration.</p>
