Both are for dual-enrollment projects and will provide TAA-certified workers with access to "wrap-around" and supportive services not covered by TAA. The full array of employment-related services will also be provided to the targeted workers not eligible for TAA. The State of Idaho will receive up to \$2,398,800, with an initial release of \$1,110,504 to serve approximately 1,000 workers affected by the layoffs at Micron Technology, Inc. located in Boise, Idaho. The payable period in the Fourth Tier for these three states began on January 3, 2010. Wisconsin has dropped below the 8.5% TUR threshold with the latest data. Maine ended its payable period for the Fourth Tier of EUC on January 3, 2010, and Wisconsin will end its payable period for the Fourth Tier of EUC on January 9, 2010.	On January 6, 2010, the Department of Labor announced nearly \$100 million in green jobs training grants, as authorized by the American Recovery and Reinvestment Act of 2009.
