Major Completed Actions (Short bulleted list of the major actions taken to date.)

The second round of Recovery Act Section 1512 Recipient Reporting began on January 1, 2010, for the period October 1, 2009 through December 31, 2009. The Employment and Training Administration (ETA) currently has 475 grantees that will be reporting through the FederalReporting.gov web site portal through January 15, 2010. ETA's national and regional offices have been working closely with grantees to ensure that guidance issued by the Office of Management and Budget is correctly implemented. ETA staff will conduct quality reviews before performance data is made public on January 30, 2010.

The recent extension of Emergency Unemployment Compensation (EUC) was for two months; EUC and other Recovery Act Unemployment Insurance programs are currently slated to phase out on February 28, 2010.

ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. As of January 15, 2010, 2,164 determinations have been made on cases received under the 2009 Amendments.

On January 13, 2010, the Department of Labor announced \$150 million in green jobs training grants, as authorized by the American Recovery and Reinvestment Act of 2009. These "Pathways Out of Poverty" grants will support programs that help disadvantaged populations find ways out of poverty and into economic self-sufficiency through employment in energy efficiency and renewable energy industries. Through the 38 grants awarded, targeted populations will receive recruitment and referral services; basic skills, work-readiness and occupational skills training; supportive services to help overcome barriers to employment; and other services at times and locations that are easily accessible. Through these programs, participants will receive certifications and on-the-job training that will lead to employment.

Employee Benefits Security Administration (EBSA)

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been almost 176,000 since the enactment of the ARRA.

EBSA now has over 55,000 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with over 2,300,000 total visitors since enactment of the ARRA.

Major Planned Actions (Short bulleted list of the major planned actions)

ETA continues to finalize the release of Recovery Act-related advisories: Training and Employment Notice (TEN) on intent to change reporting requirements for the Workforce Investment Act Standardized Record Data; and TEGL on the use of Health Coverage Tax Credit (HCTC) funds made available by the Recovery Act.

On January 15, 2010, the Department of Labor announced a \$1,661,173 grant to assist about 600 workers affected by layoffs at the Taylor, Bean and Whitaker Mortgage Corp. and its subsidiary companies in north/central Florida. Awarded to the Citrus Levy Marion Regional Workforce Development Board Inc., this grant will be operated by the Withlacoochee Workforce Development Authority Inc. It will provide affected workers with access to dislocated worker services. These services may include skills assessment, basic skills training, individual career counseling and occupational skills training. This grant will be funded by resources made available for National Emergency Grants under the Recovery Act.
