On March 23, 2010, Secretary Solis announced a National Emergency Grant (NEG) awarded to the State of Oregon to provide dislocated worker services to workers impacted by layoffs from Joe's Sports, Outdoor, Auto/Truck and More (Joe's). Joe's, a supplier of sporting goods, outdoor equipment, automotive supplies and general merchandise, closed its corporate offices, distribution center and retail stores. The award to the Workforce Investment Council of Clackamas County is for up to \$1,137,425 with an initial release of \$863,865 and will serve about 100 of the 344 workers affected by the layoffs in Wilsonville, Oregon.

On March 2, 2010, President Obama signed into law the "Temporary Extension Act of 2010," which extends Emergency Unemployment Compensation (EUC), the Federal Additional Compensation (FAC) programs as well as full funding for the Extended Benefits (EB) program. The extension is effective through April 5, 2010. There will be no "gap" in eligibility for EUC, FAC, and EB benefits. As a result, EB will remain payable in those states that had enacted temporary Total Unemployment Rate (TUR) triggers tied to full Federal funding for the EB program. The EUC program and other Recovery Act programs begin to phase out on April 5, 2010, as the Temporary Extension Act of 2010 provided a five-week extension of these programs.

Federal law currently provides for 100% Federal sharing for benefit costs under the Federal-State EB program for weeks of unemployment beginning before April 5, 2010. As a result, states that have linked the expiration of their EB TUR trigger to the termination of 100% Federal sharing for EB will soon have their triggers end and may soon cease to be in an EB period.

New York's TUR expired on March 7, 2010, and absent additional state or Federal enactments, New York's EB payable period will conclude on April 5, 2010.

Absent additional state or Federal enactments, the following states will have their EB payable period conclude on April 10, 2010: Alabama, Colorado, Delaware, Indiana, Missouri, South Carolina, Tennessee, Texas, and West Virginia.

Note that Idaho and Pennsylvania will also have their TUR triggers sunset but they currently meet the Insured Unemployment Rate (IUR) trigger criteria to remain "on" in the EB program, so their EB periods would continue until they fail to meet the criteria to be triggered "on."

The following states will have their TUR trigger expire on March 20, 2010, and have their EB payable period conclude on April 17, 2010: Arizona, the District of Columbia, Georgia, Illinois, Kentucky, Maine, Ohio, and Virginia. Note that California, Nevada and Wisconsin will also have their TUR triggers sunset but they currently meet the IUR trigger criteria to remain "on" in the EB program, so their EB periods would continue until they fail to meet the criteria to be triggered "on." The Virgin Islands will conclude its payable period in the third tier of EUC effective March 27, 2010. ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. As of March 19, 2010, 2,922 determinations have been made on cases received under the 2009 Amendments.

ETA conducted a webinar for Recovery Act Green Jobs new grantees on Wednesday, March 24, 2010. The webinar covered reporting requirements under Section 1512 of the Recovery Act and is one in a series of webinars on Recovery Act reporting.

Employee Benefits Security Administration (EBSA)

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been over 206,000 since the enactment of the ARRA.

EBSA now has over 61,000 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with over 2,695,000 total visitors since enactment of the ARRA.

EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 17,420.

ETA continues to finalize the release of Recovery Act-related advisories: Training and Employment Notice (TEN) on intent to change reporting requirements for the Workforce Investment Act Standardized Record Data; and Training and Employment Guidance Letter (TEGL) on the use of Health Coverage Tax Credit (HCTC) funds made available by the Recovery Act.

Dallas Region IV will be conducting a Recovery Act Dislocated Worker, Adult and Youth review and a Work Opportunity Tax Credit (WOTC) review in Pierre and Aberdeen, South Dakota during April 12-16, 2010.

Atlanta Region III staff will conduct a regional review of Recovery Act, Labor Market Information and Migrant and Seasonal Farm Worker (MSFW) activities in several Georgia local areas over the next three months.

Chicago Region V staff will begin its comprehensive review of all ETA-funded programs, including Recovery Act programs, in Ohio. The review will take about 6 weeks to complete and will include Region V staff representing all major program areas.

Region VI staff is planning a Recovery Act Green Jobs/Health Care new grantee orientation for June 2010 in the San Francisco bay area.
