Major Completed Actions (Short bulleted list of the major actions taken to date.)

The third round of Recovery Act Section 1512 Recipient Reporting began on April 1, 2010, for the period January 1 through March 31, 2010. The Employment and Training Administration (ETA) currently has 644 grantees that will be reporting through the FederalReporting.gov web site portal through April 10. ETA's national and regional offices have been working closely with grantees to ensure that guidance issued by the Office of Management and Budget is correctly implemented. ETA staff will conduct quality reviews before performance data is made public on April 30.

On March 2, 2010, President Obama signed into law the "Temporary Extension Act of 2010," which extends Emergency Unemployment Compensation (EUC), the Federal Additional Compensation (FAC) programs as well as full funding for the Extended Benefits (EB) program.

The current expiration date for the EUC, FAC, and EB provisions was April 5, 2010. The House passed a four-week extension of these provisions on March 17. The Senate did not pass this extension before it recessed on March 26.

Congress' two-week recess will last until April 12 – one week after the EUC, FAC, and EB provisions expire. As a result, unemployed workers will begin to lose eligibility for EUC, and in many states, for EB effective the week ending April 10.

Federal law currently provides for 100% Federal sharing for benefit costs under the Federal-State EB program for weeks of unemployment beginning before April 5, 2010. As a result, states that have linked the expiration of their EB TUR trigger to the termination of 100% Federal sharing for EB will soon have their triggers end and may soon cease to be in an EB period.

New Mexico has met the threshold to trigger "on" to a High Unemployment Period (HUP) within the EUC program and to gain access to the Fourth Tier of EUC. New Mexico's first payable week in the Fourth Tier of EUC will be the week beginning April 11, 2010. New York's Total Unemployment Rate (TUR) expired on March 7, and absent additional state or Federal enactments, New York's EB payable period concluded on April 4.

The following states had their TUR triggers expire on March 20 and will have their EB payable period conclude on April 17: Arizona, the District of Columbia, Georgia, Illinois, Kentucky, Maine, Ohio, and Virginia. Note that California, Nevada, and Wisconsin also had their TUR triggers sunset but they currently meet the Insured Unemployment Rate (IUR) trigger criteria to remain "on" in the EB program, so their EB periods will continue until they fail to meet the criteria to be triggered "on."

Absent additional state or Federal enactments, the following states will have their EB payable period conclude on April 10, 2010: Alabama, Colorado, Delaware, Indiana, Missouri, South Carolina, Tennessee, Texas, and West Virginia. Note that Idaho and Pennsylvania will also have their TUR triggers sunset but they currently meet the IUR trigger criteria to remain “on” in the EB program, so their EB periods would continue until they fail to meet the criteria to be triggered “on.”

The Green Jobs Community of Practice (CoP) Web site, launched in January 2010, has exceeded the 500-member mark. The Green Jobs CoP serves as a platform for workforce professionals and green job thought leaders to discuss and share promising practices to create partnerships for Green Job Workforce Solutions and leverage Recovery Act investments.

The Green Jobs CoP provides an interactive platform for providing technical assistance through webinars, discussion boards, blogs and other online resources to workforce professionals, particularly those at the State and Workforce Investment Board levels as well as green jobs grantees. It is a community for all federal agency workforce professionals who focus on green jobs and the workforce’s role in building a green economy. ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act took effect on May 18, 2009. As of April 2, 2010, 3,102 determinations have been made on cases received under the 2009 Amendments.

On April 12, 2010, the Department of Labor announced the availability of up to \$90 million in National Emergency Grant Recovery Act funding to create on-the-job training experiences. The money will be awarded to states that will work with state and local workforce investment boards, community-based organizations and employers in helping displaced workers acquire job skills and experiences that will improve their chances of securing permanent employment.

Employee Benefits Security Administration (EBSA)

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been 211,000 since the enactment of the ARRA.

EBSA now has 62,000 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with 2,760,000 total visitors since enactment of the ARRA.

EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 17,992.

Major Planned Actions (Short bulleted list of the major planned actions)

ETA's Atlanta Regional Office will conduct a regional review of Recovery Act, Labor Market Information and Migrant and Seasonal Farm Worker activities in several Georgia local areas over the next three months.

The Dallas Regional Office will be conducting a Recovery Act Dislocated Worker, Adult and Youth review and a Work Opportunity Tax Credit review in Pierre and Aberdeen, South Dakota from April 12-16, 2010.

The Atlanta Regional Office will participate in a Recovery Act Federal Interagency Partnership meeting on April 16, 2010 in Atlanta, Georgia.

The Atlanta Regional Office will convene a Discretionary Grantees Training Forum in Atlanta, Georgia from April 26-29, 2010. A special one-day session on Green Jobs will precede the Forum on April 25.

The Chicago Regional Office will begin its comprehensive review of all ETA-funded programs, including Recovery Act programs, in Ohio. The review will take about 6 weeks to complete.

The Chicago Regional Office will conduct a two-day YouthBuild learning exchange in Chicago on May 26-27, 2010. The event will provide an opportunity for grantee staff to learn green construction techniques and solar panel installation through hands-on exercises. The Recovery Act provided \$50 million to expand and enhance YouthBuild nationwide, as well as funding \$500 million in Green Job competitive grant opportunities some of which went to YouthBuild sites.

The San Francisco Regional Office is planning a Recovery Act Green Jobs/Health Care new grantee orientation for June 2010 in the San Francisco bay area.
