### Major Completed Actions (Short bulleted list of the major actions taken to date.)

#### Employment and Training Administration (ETA)

On April 14, 2010, the Assistant Secretary for Employment and Training testified at a hearing on Unemployment Insurance before the Senate Finance Committee entitled, “Using Unemployment Insurance to Help Americans Get Back to Work: Creating Opportunities and Overcoming Challenges.” Additional witnesses were: (1) Doug Holmes, President, Strategic Services on Unemployment and Workers Compensation and the National Foundation for Unemployment Compensation & Workers Compensation, Washington, DC; (2) Karen Lee, President, National Association of State Workforce Agencies, and Commissioner, Washington State Employment and Security Department, Olympia, WA; (3) Mark Zandi, Ph.D., Chief Economist and Cofounder, Moody's Analytics, West Chester, VA

On April 12, 2010, Secretary of Labor Hilda L. Solis announced the availability of up to \$90 million in Recovery Act National Emergency Grants funding to create on-the-job training experiences. Funds will be awarded to states that will work with state and local workforce investment boards, community-based organizations and employers in helping displaced workers acquire job skills and experiences that will improve their chances of securing permanent employment.

The third round of Recovery Act Section 1512 Recipient Reporting began on April 1, 2010, for the period January 1 through March 31, 2010. ETA had 644 grantees scheduled to report through the FederalReporting.gov web portal by April 10. However, FederalReporting.gov experienced problems in operations on April 9 and as a result the reporting deadline was extended to April 16. As of April 16, 100% of ETA’s grantees and contractors reported for this quarter. ETA is conducting data quality reviews before the data is made public on April 30.

The Continuing Extension Act of 2010 enacted on April 15, 2010, extended the phase-out period and expiration dates for Emergency Unemployment Compensation, 2008 and the Federal Additional Compensation programs, and extended the temporary provisions for the Federal-State Extended Benefits program.

On April 16, 2010, ETA published Unemployment Insurance Program Letter No. 4-10, Change 2: *Extension of Temporary Provisions - Emergency Unemployment Compensation, 2008, Federal Additional Compensation, and Extended Benefits*, to notify the workforce system of the extension of unemployment benefits.

The Recovery Act provided for a special distribution of \$7 billion in Unemployment Compensation (UC) modernization incentive payments to states. To obtain its share, a state must make an application to the Department of Labor demonstrating that its UC law contains certain benefit eligibility provisions “to reflect the nature of the 21<sup>st</sup> century economy” (Training and Employment Notice No. 27-09). As of April 12, 2010, \$2.8 billion has been distributed to a total of 32 states for UI Modernization incentive payments. Applications are under review for Maryland’s full share (100%) and Utah’s 1/3 share of UI Modernization incentive payments.

ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act which took effect on May 18, 2009. As of April 9, 2010, 3,184 determinations have been made on cases received under the 2009 Amendments.

On April 12, 2010, in conjunction with the Secretary’s announcement, ETA published Training and Employment Notice (TEN) NO. 38-09, *American Recovery and Reinvestment Act of 2009 On-the-Job Training National Emergency Grants* to announce the one-time availability of up to \$90 million in Recovery Act funding for the On-the-Job Training National Emergency Grants.

On April 7, 2010, ETA published a notice in the FEDERAL REGISTER announcing the Availability of Funds and Solicitation for Grant Applications for Category 1—Healthcare Virtual Career Platform (HVCP) and Category 2—Enhancing the Ability of Community and Faith-Based Organizations to Deliver Virtual Career Exploration Services, including Healthcare Careers. The due date for applications is May 7.

**Employee Benefits Security Administration (EBSA)**

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been 213,500 since the enactment of the ARRA.

EBSA now has 62,500 subscribers to [www.dol.gov/cobra](http://www.dol.gov/cobra) who will receive automatic notices of new or updated COBRA announcements with 2,780,000 total visitors since enactment of the ARRA.

EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 18,271.




**Major Planned Actions (Short bulleted list of the major planned actions)**

ETA's Atlanta Regional Office will conduct a regional review of Recovery Act, Labor Market Information and Migrant and Seasonal Farmworker activities in several Georgia local areas over the next three months.

The Atlanta Regional Office will convene a Discretionary Grantees Training Forum in Atlanta, Georgia from April 26-29, 2010. A special one-day session on Green Jobs will precede the Forum on April 25.

The Boston Regional Office will conduct a combined EUC/EB review in Connecticut during the week of April 26-30, 2010.

The Chicago Regional Office will begin its comprehensive review of all ETA-funded programs, including Recovery Act programs, in Ohio. The review will take about six weeks to complete.

The Chicago Regional Office will conduct a two-day YouthBuild learning exchange in Chicago on May 26-27, 2010. The event will provide an opportunity for grantee staff to learn green construction techniques and solar panel installation through hands-on exercises. The Recovery Act provided \$50 million to expand and enhance the YouthBuild program nationwide, as well as funding \$500 million in Green Job competitive grant opportunities some of which went to YouthBuild sites.

The San Francisco Regional Office is planning a Recovery Act Green Jobs/Health Care new grantee orientation for June 2010 in the San Francisco Bay area.

On April 15, 2010, the U.S. Department of Labor announced a \$465,204 grant to assist about 79 workers affected by layoffs at the Weyerhaeuser Co.'s Warrenton Sawmill in Warrenton, Oregon. Awarded to the Oregon Department of Community Colleges and Workforce Development, this grant will be operated by the Oregon Consortium and Oregon Workforce Alliance. If a Trade Adjustment Assistance petition for these dislocated workers is approved, this grant will provide them with access to “wrap-around” and supportive services, such as dependent care and transportation assistance that are not available through the TAA program. If the TAA petition is denied, the workers will have access to the full array of training and employment-related services under this grant. This grant will be funded by resources made available for National Emergency Grants under the Recovery Act.
