Staff will be on site to conduct a Recovery Act review of the State's UI Extended Benefits (EB) and Federal Additional Compensation (FAC) programs to evaluate the management and administration of these two programs; determine if the State is operating these programs in compliance with the law; and ensure achievement of the Secretary's performance goals.	
The San Francisco Regional Office held a Recovery Act Green Jobs/Health Care and Emerging Industries New Grantee Post-Award Forum on June 15-16, 2010 in the San Francisco Bay area.	
Philadelphia Regional Office Federal Project Officers conducted a Peer-to-Peer conference, YouthBuild Wellness Clinic: Increasing Your Program's Operational Health on June 15-16, 2010 in Philadelphia, PA. YouthBuild programs' health will be assessed by triaging specifically identified program challenges to address chronic problems using energizing mental toughness teambuilding activities. These activities will include brainstorming, group exercises, and discussions. The goal is for each participant to leave the session with practical take away solutions that can be implemented in their own programs. YouthBuild received \$50 million in Recovery Act funds to expand programs nationwide	
The Emergency Unemployment Compensation (EUC) program, the Federal Additional Compensation (FAC) program, and Extended Benefits (EB) provisions began to phase out on June 2, 2010, under the Continuing Extension Act of 2010. ETA continues to monitor Congressional activities related to possible EUC extensions.	
Since the EUC law expired on June 2, 2010 the last date eligibility could be established for new participants was May 22, 2010. Under the phase-out provisions, claimants may receive their remaining entitlement for the EUC tier in which they are collecting, but they may not advance to the next tier.	
<p>Federal law currently provides for 100% Federal sharing for benefit costs under the Federal-State EB program for weeks of unemployment beginning before June 2, 2010.
