<p>The Energy Training Partnership (ETP) Recovery Act High Growth and Emerging Industries Grantees webinar took place on July 8. The purpose of this Webinar is to engage grantees in an interactive discussion about their technical assistance needs and challenges.</p>	<p>On July 13, ETA will hold the State Energy Sector Partnership (SESP) and Training Grantees Webinar to provide technical assistance. ETA will be also hosting a national On-the-Job Training (OJT) National Emergency Grant (NEG) Webinar for new grantees.</p>
<p>ETA provided technical assistance to House staff on the Restoration of Emergency Unemployment Compensation Act of 2010 (HR 5618), which passed the House of Representatives on July 1, 2010. Since the Senate is in recess, no passage of an extension can occur until at least July 12, 2010. Major provisions of the House bill are as follows:</p> <ul style="list-style-type: none"> • Emergency Unemployment Compensation (EUC) and Extended Benefits Programs (EB) are extended until November 30, 2010; • The EUC "Fix" is included. The EUC "Fix" enables individuals to continue receiving EUC rather than lower weekly benefit amounts for regular UI in a second benefit year; • The "non-reduction rule" is added, which prohibits changes in calculating weekly benefit amounts (WBAs) that result in reduction in the average WBA; and • There is a new procedural requirement for EUC wherein states must ensure that individuals do not receive EUC if they are on a list of known or suspected terrorists or have been convicted of sexual offenses against minors. 	<p>The Philadelphia Regional Office has been working with the Commonwealth of Pennsylvania to replicate a successful all-state grantee roundtable hosted in Philadelphia at the Recovery Act Mid Year Review. The Commonwealth is inviting all DOL discretionary grantees in the State, and all State-funded discretionary grantees to discuss coordination of services with the workforce system formula programs. The meeting will take place on July 20, 2010.</p>
<p>Since the EUC law expired on June 2, 2010, the last date eligibility could be established for new participants was May 23, 2010. Under the phase-out provisions, claimants may receive their remaining entitlement for the EUC tier in which they are collecting, but they may not advance to the next tier.</p>	
<p>Federal law currently provides for 100% Federal sharing for benefit costs under the Federal-State EB program for weeks of unemployment beginning before June 2, 2010. As a result, states that have linked the expiration of their EB Total Unemployment Rate (TUR) trigger to the termination of 100% Federal sharing for EB are ceasing to be in an EB period.</p>	
<p>On June 18, 2010, the Bureau of Labor Statistics released new state total unemployment rates (TURs), resulting in the following:</p> <ul style="list-style-type: none"> • Vermont has triggered "off" EB. Vermont's 3-month average seasonally-adjusted TUR has decreased to 6.4%, which is below the 6.5% threshold to remain "on." Its EB period will end the week ending July 10, 2010. An extension of Federal enactments will have no effect on Vermont's EB status. • Colorado has met the TUR criteria to be in a High Unemployment Period in the EB program. However, Colorado is currently "off" EB because its TUR trigger is tied to the termination of 100% Federal sharing. Should additional state or Federal enactments create a retroactive coverage period, Colorado would remain in an EB period and would begin a mandatory 13-week High Unemployment Period, beginning July 4, 2010. 	
<p>Absent additional state or Federal enactments, the following changes will take place:</p> <ul style="list-style-type: none"> • Michigan's TUR trigger expired on June 5, 2010 and its EB payable period will conclude on July 3, 2010. 	

<p>The Recovery Act provided for a special distribution of \$7 billion in Unemployment Insurance (UI) Modernization incentive payments to states:</p> <ul style="list-style-type: none"> • On July 7, 2010, the Department of Labor announced the release of \$43.6 million in UI modernization incentive funds to the state of Nebraska. Nebraska qualified for its full share of the funds available under the American Recovery and Reinvestment Act by adding new provisions to its UI law that assist recent entrants to the workforce, part-time workers and people who are upgrading their skills. Nebraska can use the funds to pay unemployment benefits or, if appropriated by the legislature, for administering its unemployment insurance program or delivering employment services. • ETA expects to receive applications for full (100%) incentive payments from North Carolina and South Carolina. South Carolina recently enacted legislation that includes provisions related to the requirements for receiving 100% of UI Modernization incentive payments. 	
<p>On June 29, 2010, ETA regional staff coordinated a conference call with Workforce West Virginia and the Boston and Dallas Regions to identify short term and long term goals for the use of Recovery Act Temporary Assistance for Needy Families (TANF) Emergency Funds in the Regions. A conference call with all ETA Regional Offices will be scheduled for the week of July 9, 2010 to expand these goals and prepare for a meeting with the Department of Health and Human Resources.</p>	
<p>ETA approved waivers for the States of Texas and Montana that provide program design and performance flexibility in order to facilitate summer youth employment opportunities with Workforce Investment Act of 1998 and TANF funds made available under the Recovery Act.</p>	
<p>ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act which took effect on May 18, 2009. During the week of June 28 through July 2, 2010, a total of 55 determinations were issued, 4,185 determinations have been issued on cases received under the 2009 Amendments.</p>	
<p>The fourth round of Recovery Act Section 1512 Recipient Reporting will began on July 1, 2010, for the period April 1, 2010 through June 30, 2010. National and Regional Offices are providing technical assistance to grantees that will report on the FederalReporting.gov web site portal through July 10, 2010 and working closely with grantees to ensure that guidance issued by the Office of Management and Budget is correctly implemented. ETA staff will conduct quality reviews before performance data is made public on July 30, 2010.</p>	
<p>Employee Benefits Security Administration (EBSA)</p>	
<p>EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been 238,200 since the enactment of the ARRA.</p>	
<p>EBSA now has 74,850 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with 3,195,000 total visitors since enactment of the ARRA.</p>
