Financial and Activity Report (sheet 2 of 2)

Major Completed Actions (Short bulleted list of the major actions taken to date.)

On July 14, 2010 ETA staff met with the National Governors Association to continue implementing the Cooperative Agreement to provide technical assistance to the Recovery Act High Growth Emerging Industries grantees. The purpose of this meeting was to begin prioritizing activities, assigning tasks, and identifying timelines.

On July 16, 2010 ETA and state and local staff, will present the On the Job Training (OJT) Toolkit to the OJT National Emergency Grant (NEG) grantees. The Toolkit is a repository of OJT templates and forms including outreach materials, contracts, and monitoring documents that are customizable for OJT NEG grantees. Presentations from states and locals will address using OJT as a strategic tool to get dislocated workers back to work.

On July 16, 2010 ETA will conduct a technical assistance (TA) Webinar for the Health Care and Other Emerging Industries Grantees, which are Recovery Act High Growth and Emerging Industries Grantees. The purpose of this Webinar is to engage grantees in an interactive discussion about their TA needs and challenges. This information will continue to inform our comprehensive TA planning efforts. We will also launch the SGA-specific Community of Practice designed to provide Health Care and Other Emerging Industries grantees with access to an array of grant-specific resources, and the ability to participate in real-time discussions with their peers.

The House of Representatives passed HR 5618 on July 1, 2010. The Senate returned from recess on July 12, 2010 and is expected to begin consideration of an extension bill. Major provisions of the House bill are as follows:

- Emergency Unemployment Compensation (EUC) and Extended Benefits Programs (EB) are extended until November 30, 2010;
 - The EUC "Fix" is included. The EUC "Fix" enables individuals to continue receiving EUC rather than lower weekly benefit amounts for regular UI in a second benefit year;
- The "non-reduction rule" is added, which prohibits changes in calculating weekly benefit amounts (WBAs) that result in reduction in the average WBA;
- There is a new procedural requirement for EUC wherein states must ensure that individuals do not receive EUC if they are on a list of known or suspected terrorists or have been convicted of sexual offenses against minors.

Since the EUC law expired on June 2, 2010, the last date eligibility could be established for new participants was May 23, 2010, in order to have EUC Tier One eligibility. Under the phase-out provisions, claimants may receive their remaining entitlement for the EUC tier in which they are collecting, but they may not advance to the next tier.

Federal law currently provides for 100% Federal sharing for benefit costs under the Federal-State EB program for weeks of unemployment beginning before June 2, 2010. As a result, states that have linked the expiration of their EB Total Unemployment Rate (TUR) trigger to the termination of 100% Federal sharing for EB are ceasing to be in an EB period.

On June 18, 2010 the Bureau of Labor Statistics released new state total unemployment rates (TURs), resulting in the following:

- Vermont has triggered "off" EB. Vermont's 3-month average seasonally-adjusted TUR has decreased to 6.4%, which is below the 6.5% threshold to remain "on." Its EB period ended the week ending July 10, and Vermont begins a mandatory 13-week "off" period. An extension of Federal enactments will have no effect on Vermont's EB status.
- Colorado has met the TUR criteria to be in a High Unemployment Period in the EB program. However, Colorado is currently "off" EB because its TUR trigger is tied to the termination of 100% Federal sharing. Should additional state or Federal enactments create a retroactive coverage period, Colorado would remain in an EB period and would begin a mandatory 13-week High Unemployment Period, beginning July 4.

The Recovery Act provided for a special distribution of \$7 billion in Unemployment Insurance (UI) Modernization incentive payments to states. An application is pending for South Carolina for its full share of incentive payments. South Carolina recently enacted legislation that includes provisions related to the requirements for receiving 100% of UI Modernization incentive payments.

ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act which took effect on May 18, 2009. A total of 4,257 determinations have been issued on cases received under the 2009 Amendments.

The fourth round of Recovery Act Section 1512 Recipient Reporting began on July 1, 2010, for the period April 1, 2010 through June 30, 2010. The Recovery Accountability and Transparency Board extended the reporting deadline through July 15, 2010.

National and Regional Office staff continue to provide technical assistance to grantees to ensure that guidance issued by the Office of Management and Budget is correctly implemented. ETA expects to have 654 grantees report through the FederalReporting.gov web site portal. ETA National and Regional Office staff will conduct quality reviews before performance data is made public on July 30, 2010.

ETA staff will conduct a review of the EB and EUC programs in Montana, Tennessee, and West Virginia during the week of July 19, 2010.

Employee Benefits Security Administration (EBSA)

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been 240,350 since the enactment of the ARRA.

EBSA now has 75,350 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with 3,225,000 total visitors since enactment of the ARRA.

Major Planned Actions (Short bulleted list of the major planned actions)

The Philadelphia Regional Office has been working with the Commonwealth of Pennsylvania to replicate a successful all-state grantee roundtable hosted in Philadelphia at the Recovery Act Mid-Year Review. The Commonwealth is inviting all DOL discretionary grantees in the State and all State-funded discretionary grantees to discuss coordination of services with the workforce system formula programs. The meeting will take place on July 20, 2010.
