<p>The Philadelphia Regional Office has been working with the Commonwealth of Pennsylvania to replicate a successful all-state grantee roundtable hosted in Philadelphia at the Recovery Act Mid-Year Review. The Commonwealth invited all DOL discretionary grantees in the State and all State-funded discretionary grantees to discuss coordination of services with the workforce system formula programs. South Carolina recently enacted legislation that includes provisions related to the requirements for receiving 100% of UI Modernization incentive payments.
