This provision stems from the \$25 supplement payable under the FAC program to individuals</li> </ul>	
<p>Since Federal law currently provides for 100% Federal funding for sharable benefit costs under the federal-state EB program for unemployment beginning before November 30, 2010, states that have linked the expiration of their EB Total Unemployment Rate (TUR) trigger to the termination of 100% Federal sharing for EB will resume their EB periods.</p>	
<p>The following states that had their triggers expire will resume their EB periods: Alabama, Arizona, California, Colorado, Delaware, the District of Columbia, Georgia, Idaho, Illinois, Indiana, Kentucky, Maine, Massachusetts, Michigan, Missouri, Nevada, New York, Ohio, Pennsylvania, South Carolina, Tennessee, Texas, Virginia, West Virginia and Wisconsin.</p>
