<p>On August 9 and 10, 2010, the American Association of Community Colleges (AACC) hosted the first meeting of its Advisory Panel for the Healthcare Virtual Career Platform project and a meeting with the Category 2 Community Based Organization capacity-building grantees. ETA staff participated in portions of the meetings. The Recovery Act provided funding for the Healthcare Virtual Career Platform through a competitive grant solicitation.</p>	<p>ETA Regional Office staff will be on site in Vermont the week of August 16, 2010, conducting an ARRA review of the state's On-the-Job Training program.</p>
<p>ETA convened an all-grantee meeting for On-the-Job Training National Emergency Grants in Washington, D.C. on August 10 and 11, 2010. There were approximately 100 grantees and others in attendance.</p>	
<p>On July 22, 2010, the President signed the Unemployment Compensation Extension Act of 2010 (P.L. No. 111-205). With the exception of the Emergency Unemployment Compensation (EUC) "Fix," the provisions of the Act are retroactive, and there is no gap between the June 2, 2010, expiration date of the previous legislation and this Extension Act.</p>	
<p>New Mexico, New York and Wisconsin will trigger "off" of the Fourth Tier in the EUC program. The payable period in the Fourth Tier will conclude for New Mexico and Wisconsin on August 14, 2010, and for New York on August 15, 2010.</p>	
<p>The Recovery Act made a total of \$7 billion in unemployment insurance modernization incentive payments available to states that include certain eligibility provisions in their programs. <p>On August 10, 2010, the Department released \$97,459,490 in unemployment insurance modernization incentive funds to the State of South Carolina for its full share of the Recovery Act funds. The state qualified for its full share of funding by enacting a variety of provisions that allow more workers who lose jobs through no fault of their own to receive unemployment compensation. This group includes recent entrants to the workforce, part-time workers, and those who become unemployed due to compelling family reasons. The South Carolina Department of Employment and Workforce will use funds to pay unemployment benefits or, if appropriated by the legislature, to administer the state unemployment insurance program.</p>	
<p>On August 9, 2010, the Department released \$15,640,385 in unemployment insurance modernization incentive funds to Rhode Island. The state qualified for the remaining two-thirds of its share of funds by updating state unemployment insurance laws to include certain family-friendly provisions. The Rhode Island Department of Labor and Training can use the funds to pay unemployment benefits or, if appropriated by the state legislature, to administer the state unemployment insurance program.</p>

<p>EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been 246,000 since the enactment of the ARRA.</p>
