State Fiscal Stabilization Fund--Education

The ARRA established the State Fiscal Stabilization Fund (SFSF) as a block grant to be distributed by the governors of each state to assist in stabilization of state budgets during the 08-09 and 09-10 fiscal years. The SFSF funds were available to all LEAs, State Educational Agencies, and State institutions of Higher Education.

*SFSF funds were used to support full-time employees only and each employee equals 1 FTE position unless split-coded. If a position is split-coded, the FTE reported represents the portion of the base salary supported by SFSF funds.

Instructional includes the number of FTE positions (and the corresponding amount of SFSF funds supporting the salaries and related benefits of these positions) that provide curriculum instruction in associate's degree, diploma, and transitional programs.

Non-Instructional includes the number of FTE positions (and the corresponding amount of SFSF funds supporting the salaries and related benefits of these positions) involved in curriculum program administration, student services, and general administration of the institution (excluding plant management and executive management).

Equipment Assistance Grants

The amount of funds available for Equipment Assistance Grants was **\$3,313,727.00**. State Board of Education (SBE) procedures for the competitive/discretionary grant proposal review process, as described in SBE Policy EEO-O-001, were followed. The following is a synopsis of the grant fund proposals and proposed distribution of funds:

120 School Food Authorities submitted proposals for a total of \$11,085,586.80.

- 102 LEAs (1,058 schools) \$10,701,794.06
- 10 Charter Schools \$ 206,708.91
- 1 Non-Public School \$ 13,133.00
- 7 Residential Child Care Institutions (RCCIs) \$ 163,950.83

109 School Food Authorities are recommended for grants for a total of \$3,313,724.62.

- 95 LEAs (255 schools) \$3,165,992.46
- 8 Charter Schools \$ 99,195.22
- 6 RCCIs \$ 48,536.94

On June 4, 2009, the State Board of Education unanimously approved the following School Food Authorities (SFAs) to be awarded Equipment Assistance Grants provided by the American Recovery and Reinvestment Act of 2009. These funds will be used to purchase food preparation and service equipment for use in the SFA's Child Nutrition Program.
