## **BRAND INFORMATION**

1. Make a small sketch of your first choice of brand on the attached diagram and the exact size of the brand on the accompanying sketch form.
2. Sketch your second and third choice in the appropriate spaces on the front of this form. Give three choices to avoid a delay in issuance of certificate. A particular brand may be registered to only person, firm, or corporation in Illinois. (Duplicate brands will not be registered.)
3. Indicate location of brand on the animal diagram as shoulder, ribs (rather than side), and hip. The thigh is included in the "hip" location.
4. Brand is a permanent identification mark of which the letters, numbers, and figures are not less than three inches in diameter and each shall be a distinct character. Brands of lesser dimensions may be approved by the Department when used for goats, sheep, and swine. Arabic numerals alone are not acceptable characters for such ownership brands.
5. Precaution should be taken to avoid all brands that blotch easily.
6. Do not use brand on animals until the brand is approved by the Illinois Department of Agriculture.
7. Brand plainly and carefully for your protection.

**CANCELLATION OR ABANDONMENT:** Failure to renew a mark or brand on or before the time specified results in the forfeiture of the brand. The owner may make application for reinstatement of a forfeited brand within five years. The fee for reinstatement is \$25.00.

**TRANSFER:** Any recorded brand shall be considered the personal property of the owner and is subject to sale, assignment, transfer, legacy, and descent. Instruments of writing evidencing the sale, assignment, or transfer of a brand shall be forwarded to the Department, along with transaction fee of \$15.00.
