**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL  
DETERMINATION GRANTING COMPLAINANT'S MOTION FOR SUMMARY  
DETERMINATION THAT IT HAS ESTABLISHED THE IMPORTATION  
REQUIREMENT OF SECTION 337 AS TO RESPONDENT GRIFFIN TECHNOLOGY INC.**

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 28) granting Complainant's summary determination that it has established the importation requirement of section 337 as to Respondent Griffin Technology, Inc. of Nashville, Tennessee ("Griffin").

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on June 30, 2011, based on a complaint filed by Otter Products, LLC of Fort Collins, Colorado ("Otter"). 76 *Fed. Reg.* 38417 (June 30, 2011). The complaint alleged violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337 in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain protective cases and components thereof by reason of infringement of various claims of United States Patent Nos. 7,933,122; D600,908; D617,784; D615,536; D617,785; D634,741; and D636,386; and United

States Trademark Registration Nos. 3,788,534; 3,788,535; 3,623,789; and 3,795,187. The notice of investigation named several respondents, however, except for the respondents who defaulted, only Griffin remains in the investigation.

On January 30, 2012, Otter filed a motion for summary determination that it has satisfied the importation requirement of section 337 as to Griffin. No responses to the motion were received.

On March 16, 2012, the ALJ issued the subject ID, granting the summary determination motion. The ALJ found that pursuant to Commission Rule 210.18 (19 C.F.R. § 210.18), the undisputed facts establish that Griffin imports and sells the accused protective cases. None of the parties petitioned for review of the ID.

The Commission has determined not to review the ID. Accordingly, Otter has established the importation requirement of section 337 with respect to Griffin.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
