### Chamber Action

*Routine Proceedings, pages S295–S348*

**Measures Introduced:** Thirteen bills and six resolutions were introduced, as follows: S. 211–223, and S. Res. 28–33. **Page S338**

#### Measures Passed:

**Publicly Disclose Objection Resolution:** By 92 yeas to 4 nays (Vote No. 2), Senate agreed to S. Res. 28, to establish as a standing order of the Senate that a Senator publicly disclose a notice of intent to objecting to any measure or matter. (A unanimous-consent agreement was reached providing that the resolution, having achieved 60 affirmatives votes, be agreed to.) **Pages S296, S304–326**

**Reading of Amendment Resolution:** By 81 yeas to 15 nays (Vote No. 3), Senate agreed to S. Res. 29, to permit the waiving of the reading of an amendment if the text and adequate notice are provided. (A unanimous-consent agreement was reached providing that the resolution, having achieved 60 affirmatives votes, be agreed to.) **Pages S296, S327**

**110th Anniversary of the United States Army Nurse Corps:** Senate agreed to S. Res. 31, commemorating the 110th anniversary of the United States Army Nurse Corps. **Pages S345–46**

**National Teen Dating Violence Awareness and Prevention Month:** Senate agreed to S. Res. 32, designating the month of February 2011 as “National Teen Dating Violence Awareness and Prevention Month”. **Pages S346–47**

**150th Anniversary of the Admittance of the State of Kansas:** Senate agreed to S. Res. 33, expressing the sense of the Senate relating to the 150th anniversary of the admittance of the State of Kansas to the United States as the 34th State. **Page S347**

#### Measures Failed:

**Cloture Resolution:** By 12 yeas to 84 nays (Vote No. 4), two-thirds of the Senators voting, a quorum being present, not having voted in the affirmative, Senate failed to agree to S. Res. 8, amending the Standing Rules of the Senate to provide for cloture

to be invoked with less than a three-fifths majority after additional debate, and was returned to the calendar over, under the rule. **Pages S296, S327**

**Debate Improvement Resolution:** By 44 yeas to 51 nays (Vote No. 5), two-thirds of the Senators voting, a quorum being present, not having voted in the affirmative, Senate failed to agree to S. Res. 10, to improve the debate and consideration of legislative matters and nominations in the Senate, and was returned to the calendar over, under the rule, after taking action on the following amendment proposed thereto: **Pages S296–97, S328**

**Extended Debate Resolution:** By 46 yeas to 49 nays (Vote No. 6), two-thirds of the Senators voting, a quorum being present, not having voted in the affirmative, Senate failed to agree to S. Res. 21, to amend the Standing Rules of the Senate to provide procedures for extended debate, and was returned to the calendar over, under the rule, after taking action on the following amendment proposed thereto: **Pages S297–S304, S328–29**
