### Chamber Action

*Routine Proceedings, pages S3571–S3630*

**Measures Introduced:** Six bills and three resolutions were introduced, as follows: S. 1155–1160, S.J. Res. 18, and S. Res. 205–206. **Page S3613**

#### Measures Passed:

**Polycystic Kidney Disease Awareness Week:** Senate agreed to S. Res. 205, designating the period beginning on June 19, 2011, and ending on June 25, 2011, as “Polycystic Kidney Disease Awareness Week”, and raising awareness and understanding of polycystic kidney disease and the impact such disease has on patients. **Page S3629**

**American Eagle Day:** Senate agreed to S. Res. 206, designating June 20, 2011, as “American Eagle Day”, and celebrating the recovery and restoration of the bald eagle, the national symbol of the United States. **Pages S3629–30**

#### Measures Considered:

**Economic Development Revitalization Act—Agreement:** Senate continued consideration of S. 782, to amend the Public Works and Economic Development Act of 1965 to reauthorize that Act, taking action on the following amendments proposed thereto: **Pages S3579–S3607**

#### Rejected:

By 54 yeas to 45 nays (Vote No. 86), Tester Amendment No. 392, to improve the regulatory structure for electronic debit card transactions. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, the amendment was not agreed to.) **Pages S3579–94**

S. 911, to establish the sense of Congress that Congress should enact, and the President should sign, bipartisan legislation to strengthen public safety and to enhance wireless communications, with an amendment in the nature of a substitute;

S. 962, to reauthorize the Northwest Straits Marine Conservation Initiative Act to promote the protection of the resources of the Northwest Straits; and
